PURPOSE:

To allow ex-officio members of the Board of Agriculture to designate a representative to attend board meetings when they are unable

to attend.

MEANS:

Amend section 26-16(a), Hawaii Revised

Statutes (HRS).

JUSTIFICATION:

Currently, section 26-16 requires that the Board of Agriculture be made up of 10 members, three of which are ex officio voting members: the Chairperson of the Board of Land and Natural Resources, the Director of Business, Economic Development, and Tourism, and the Dean of the University of Hawaii College of Tropical Agriculture and Human Resources. Often, the busy schedules of these ex officio members make it extremely difficult for them to attend board meetings and their inability to attend can result in the lack of their department's unique insight on board agenda items, as well as quorum issues for the board.

Allowing the ex officio members to designate a representative will be a step toward ensuring the unique perspectives provided by the Department of Land and Natural Resources, the Department of Business, Economic Development, and Tourism, and the University of Hawaii College of Tropical Agriculture and Human Resources can be expressed at board meetings. It would also help to solve any quorum issues that could arise from an insufficiency of board members.



This amendment is not without precedent. Currently, the board of the Agribusiness Development Corporation has language that allows ex officio members to designate representatives. Section 163D-3(b), Hawaii Revised Statutes, in describing the members of the board requires "The director of business, economic development, and tourism; the chairperson of the board of agriculture; and the chairperson of the board of land and natural resources, or their designated representatives, shall be ex-officio, voting members of the board".

Impact on the public: Would allow ex officio members to designate representatives to attend board meetings, increasing the likelihood that unique insight from their respective areas of expertise would be available to the board to ensure a more complete consideration of board agenda items. Would also potentially solve any quorum issues that arise, ensuring that board meetings will happen and would decrease delays as a result of a cancelled board meeting.

Impact on the department and other agencies: Would ensure that the unique perspectives of each of the ex officio members' departments would be properly represented in deliberations over agenda items. Would also provide more flexibility to the Chair of the Board of Land and Natural Resources, the Director of the Board of Business, Economic Development, and Tourism, and the Dean of the University of Hawaii College of Tropical Agriculture and Human Resources. Would also ensure a more efficient process due to the decreased likelihood of quorum issues occurring that can delay agenda items.
