### A BILL FOR AN ACT

RELATING TO DRIVERS' LICENSES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature recognizes that there is a need 2 to expand the availability of remedies for nonpayment of 3 judgments in chapter 287, Hawaii Revised Statutes, to state, 4 county, and city agencies. The purpose of this Act is to allow 5 a state, county, or city governmental agency to send a certified 6 copy of a judgment issued by a court, or an administrative order 7 issued pursuant to a hearing held under chapter 91, Hawaii 8 Revised Statutes, in which a person was determined to owe a debt 9 to a governmental agency to the administrator of chapter 287. 10 Upon receipt of the judgment or order, the administrator shall 11 suspend the driver's license of, or deny the issuance of a 12 driver's license to, any person who has failed to pay a debt 13 owed to the governmental agency. 14 SECTION 2. Section 287-1, Hawaii Revised Statutes, is 15 amended by adding two new definitions to be appropriately 16 inserted and to read as follows: 17 ""Agency" means each state or county board, commission,

department, or officer authorized by law to adjudicate contested

- 1 cases or any state, county, or city governmental agency charged 2 with collecting a debt owed to a governmental agency. "Order" means an order issued pursuant to a hearing held in 3 4 accordance with chapter 91." 5 SECTION 3. Section 287-1, Hawaii Revised Statutes, is 6 amended by amending the definition of "judgment" to read as 7 follows: 8 ""Judgment" means any judgment, order, or decree which has 9 become final by expiration without appeal of the time within 10 which an appeal might have been perfected, or by final 11 affirmation on appeal, rendered by a court of competent 12 jurisdiction of the United States or any territory or state 13 thereof upon a cause of action arising out of the ownership, 14 maintenance, or use of any motor vehicle for damages, including

1 "§287-15 Report of nonpayment of judgments. (a) Whenever 2 any person fails within sixty days to satisfy any judgment upon 3 the written request of the judgment creditor or the judgment 4 creditor's attorney, the clerk of the court or the judge of a 5 court which has no clerk in which any such judgment is rendered 6 shall forward to the administrator immediately after the 7 expiration of the sixty days a certified copy of the judgment. Whenever any person fails within sixty days to satisfy 8 9 a judgment or order to pay a debt owed to a state, county, or 10 city governmental agency, the agency may forward a certified 11 copy of the judgment or order to the administrator. **12** (c) If the defendant named in any certified copy of a 13 judgment or order reported to the administrator is a 14 nonresident, the administrator shall transmit a certified copy 15 of the judgment or order to the official in charge of the 16 issuance of licenses and registration certificates of the state **17** of which the defendant is a resident." **18** SECTION 5. Section 287-16, Hawaii Revised Statutes, is 19 amended to read as follows: 20 "§287-16 Suspension for nonpayment of judgment; 21 exceptions. The administrator, upon the receipt of a certified 22 copy of the judgment or order shall forthwith suspend the

TITLE:

A BILL FOR AN ACT RELATING TO DRIVERS'

LICENSES.

PURPOSE:

To allow a state, county, or city governmental agency to send a certified copy of a judgment or administrative order to the Administrator under chapter 287, Hawaii Revised Statutes, requesting and authorizing the Administrator to suspend or deny the issuance of a driver's license of an individual who has owed to a state, county, or city governmental agency.

MEANS:

Amend sections 287-1, 287-15, and 287-16,

Hawaii Revised Statutes.

JUSTIFICATION:

Under current law, an individual's driver's license may be suspended only when a court issues a judgment in a case arising out of the owernership, maintenance or use of a motor vehicle for damages, and a person fails to satisfy the judgment within sixty days. Upon the judgment creditor's request, the court sends a copy of a certified judgment to the Administrator of chapter 287 who then suspends the defendant's driver's license.

State, county, and city governmental agencies need an alternative to costly and extensive litigation to motivate individuals to pay a debt owed to a governmental agency. This can be accomplished where it is confirmed by a court or at an administrative hearing that a person owes a debt to a governmental agency. If the person fails to pay the debt within sixty days of the issuance of a judgment by a court or an order following an administrative hearing, a

certified copy of the judgment or administrative order may be sent to the Administrator requesting that a person's driver's license be suspended or that the person be denied the issuance of a driver's license.

Impact on the public: This bill will benefit the public interest because state, county, and city governmental agencies would be able to collect debts quicker and use the funds to provide continued services to the public.

Impact on the department and other agencies: This bill will help the department and other agencies by giving debtors an incentive to pay debts that they owe to governmental agencies.
