A BILL FOR AN ACT

RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Pursuant to chapter 206E, Hawaii Revised
- 2 Statutes, the Hawaii community development authority is tasked
- 3 with the redevelopment responsibilities for legislatively
- 4 created community development districts. The legislature has
- 5 designated three community development districts: Kakaako,
- 6 Kalaeloa, and Heeia.
- 7 Currently, section 206E-14, Hawaii Revised Statutes, allows
- 8 the authority to sell or lease for a term not exceeding sixty-
- 9 five years, all or any portion of its real or personal property
- 10 constituting a redevelopment project if the authority finds that
- 11 the sale or lease is in conformity with the community
- 12 development plan. As defined in section 206E-2, Hawaii Revised
- 13 Statutes, a redevelopment project may only be incidental in its
- 14 commercial nature. The legislature finds that this limitation
- 15 adversely impacts the authority's ability to attract long-term
- 16 investors and tenants who seek to develop or redevelop primarily
- 17 commercial projects within the Kakaako community development
- 18 district. This conflicts with the authority's commitment to HB2482 HD1 HMS 2012-2439



- 1 implement longer lasting change in the Kakaako community
- 2 development district.
- 3 In addition, although section 206E-14, Hawaii Revised
- 4 Statutes, provides that a sale may be made without recourse to
- 5 public auction, the section is silent as to whether a lease may
- 6 be made without recourse to public notice for sealed bids.
- 7 The purpose of this Act is to provide greater flexibility
- 8 to the authority in implementing its master plan for the Kakaako
- 9 community development district by allowing the authority to
- 10 lease:
- 11 (1) For a term not exceeding sixty-five years property
- 12 constituting a project (as opposed to selling the
- project, or leasing or selling a redevelopment
- 14 project); and
- 15 (2) A project without recourse to public notice for sealed
- 16 bids;
- in the Kakaako community development district.
- 18 The legislature further finds, that safeguards remain in
- 19 place because all long-term leases require prior approval by the
- 20 authority at a publicly noticed meeting and after opportunity
- 21 for public comment.

         SECTION 2. Chapter 206E, Hawaii Revised Statutes, is
 2
    amended by adding a new section to part II to be appropriately
 3
    designated and to read as follows:

         "§206E- Lease of projects. (a) Notwithstanding any
 5
    law to the contrary, including 206E-14, except as prohibited by
 6
    section 206E-31.5, the authority may, without recourse to public
7
    auction or public notice for sealed bids, lease for a term not
8
    exceeding sixty-five years all or any portion of the real or
9
    personal property constituting a project to any person, upon
10
    such terms and conditions as may be approved by the authority,
11
    if the authority finds that the lease is in conformity with the
12
    community development plan.
         (b) In the case of any sale of the leasehold interest in
13
    the project, the terms of the sale shall provide for the
14
15
    repurchase of the leasehold property by the authority at its
16
    option, in the event that the purchaser, if other than a state
17
    agency, desires to sell the property within ten years; provided
18
    that this requirement may be waived by the authority if the
19
    authority determines that a waiver will not be contrary to the
20
    community development plan. The authority shall establish at
21
    the time of original sale a formula setting forth a basis for a
22
    repurchase price based on market considerations including but
```

- 1 not being limited to interest rates, land values, construction
- 2 costs, and federal tax laws.
- 3 If the purchaser in a residential project is a state
- 4 agency, the authority may include as a term of the sale a
- 5 provision for the repurchase of the property in conformance with
- 6 this section."
- 7 SECTION 3. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect upon its approval.
