A BILL FOR AN ACT

RELATED TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the early childhood
- 2 years from birth to age five are critical to an individual's
- 3 long-term health and educational success.
- 4 Research has found that over eighty-five per cent of a
- 5 child's brain development happens by age five in response to the
- 6 stimulation the child receives. Children's early experiences,
- 7 from birth to age five, lay the groundwork for a child's
- 8 lifelong learning and behavior. Studies have shown that high
- 9 quality preschool programs directly impacts school readiness.
- 10 There is now evidence that high quality preschool, along with
- 11 full-day kindergarten maximize the chances of children having
- 12 strong third grade reading results.
- 13 In addition, research finds that investing in high quality
- 14 early learning programs produces significant returns later. In
- 15 Hawaii, every \$1 spent on high quality early childhood education
- 16 realizes a \$4.20 reduction in costs for future educational and
- 17 social interventions. In 2011, the department of education
- 18 reported that state-wide, approximately forty-two per cent of



- 1 Hawaii's public school kindergarten students did not attend
- 2 preschool. In a November 27, 2011, Hawaii Star Advertiser
- 3 article, it was reported that elementary school principals and
- 4 child advocates say kindergarteners without preschool experience
- 5 are more likely to enter school far behind their peers.
- 6 To improve the educational outcomes of Hawaii's people, we
- 7 must promote our children's school readiness through high
- 8 quality early learning experiences and beginning with high
- 9 quality preschool that is affordable and accessible. High
- 10 quality preschool will not only lead to better educational
- 11 outcomes in kindergarten and third grade, it will also reduce
- 12 costs for educational and social interventions later.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$500,000 or so much
- 15 thereof as may be necessary for fiscal year 2012-2013 to provide
- 16 funding for the early learning council and the governor's early
- 17 childhood coordinator to further develop and implement a
- 18 comprehensive early childhood system and to develop, execute,
- 19 and monitor a phased implementation plan for a public-private
- 20 preschool program for four-year olds, including a financial
- 21 business plan with potential sources of sustainable revenue.

- 1 The sum appropriated shall be expended by the department of
- 2 education for the purposes of this Act.
- 3 SECTION 3. This Act shall take effect on July 1, 2012.
