A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the early childhood
- 2 years from birth to age five are critical to an individual's
- 3 long-term health and educational success.
- 4 Research has found that over eighty-five per cent of a
- 5 child's brain development happens by age five in response to the
- 6 stimulation the child receives. Children's early experiences,
- 7 from birth to age five, lay the groundwork for a child's
- 8 lifelong learning and behavior. Studies have shown that high
- 9 quality preschool programs directly impact school readiness.
- 10 There is now evidence that high quality preschool programs,
- 11 along with full-day kindergarten classes, maximize the chances
- 12 of children having strong third grade reading results.
- In addition, research finds that investing in high quality
- 14 early learning programs produces significant returns. In
- 15 Hawaii, every \$1 spent on high quality early childhood education
- 16 realizes a \$4.20 reduction in costs for future educational and
- 17 social interventions. In 2011, the department of education
- 18 reported that statewide, approximately forty-two per cent of

- 1 Hawaii's public school kindergarten students did not attend
- 2 preschool. In a November 27, 2011, Honolulu Star-Advertiser
- 3 article, it was reported that elementary school principals and
- 4 child advocates believe that kindergarteners without preschool
- 5 experience are more likely to enter school far behind their
- 6 peers.
- 7 To improve the educational outcomes of Hawaii's people, we
- 8 must promote our children's school readiness through high
- 9 quality early learning experiences and beginning with high
- 10 quality preschool that is affordable and accessible. High
- 11 quality preschool will not only lead to better educational
- 12 outcomes in kindergarten and third grade, it will also reduce
- 13 costs for subsequent educational and social interventions.
- 14 The purpose of this Act is to appropriate funds to further
- 15 the development and implementation of a comprehensive early
- 16 childhood system and preschool program.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so
- 19 much thereof as may be necessary for fiscal year 2012-2013 to
- 20 provide funding for the early learning council and the
- 21 governor's early childhood coordinator to further develop and
- 22 implement a comprehensive early childhood system and to develop,



- 1 execute, and monitor a phased implementation plan for a public-
- 2 private preschool program for four-year olds, including a
- 3 financial business plan with potential sources of sustainable
- 4 revenue.
- 5 The sum appropriated shall be expended by the department of
- 6 education for the purposes of this Act.
- 7 SECTION 3. This Act shall take effect on July 1, 2030.
