### A BILL FOR AN ACT

RELATING TO THE HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness is a
- 2 complex and multifaceted issue requiring planning, coordination,
- 3 implementation, and funding across federal, state, local,
- 4 business, and community lines. Locally, many government
- 5 agencies, nonprofit organizations, and other private sector
- 6 organizations have worked diligently and successfully to assist
- 7 those who are homeless. Yet, Hawaii has experienced an increase
- 8 in the number of homeless individuals and families.
- 9 According to 2009 data, Hawaii has twice as many people who
- 10 are homeless per 100,000 people as the national average. The
- 11 2011 State-wide Point in Time Count indicated a six per cent
- 12 increase in homelessness throughout the State. Further, 2010
- 13 data indicate that almost one third of the sheltered homeless
- 14 are children; more than ten per cent are veterans; over sixty
- 15 per cent have lived in Hawaii for more than ten years; almost
- 16 half of the families who are homeless include someone who is
- 17 employed; and almost thirty per cent are Hawaiian or part

- 1 Hawaiian; thus, showing that there is no single profile of
- 2 someone who is homeless.
- In January 2011, the governor of the State of Hawaii
- 4 pronouncing the elimination of homelessness a "moral
- 5 imperative", appointed the first governor's coordinator on
- 6 homelessness, to lead the effort to prevent and eliminate
- 7 homelessness in Hawaii through the use of strategic approaches,
- 8 structural changes, and unprecedented collaborative and civic
- 9 involvement.
- 10 On March 4, 2011, the governor of the State of Hawaii
- 11 hosted with the United States Department of Veterans Affairs, an
- 12 interagency leadership forum on homelessness attended by leaders
- 13 from government, business, the community, and the faith
- 14 community, to advocate for the development of a collaborative
- 15 strategy to end homelessness in Hawaii.
- 16 On June 22, 2010, the United States Interagency Council on
- 17 Homelessness, comprised of nineteen Cabinet Secretaries and
- 18 agency heads, released "Opening Doors: Federal Strategic Plan to
- 19 Prevent and End Homelessness", the nation's first comprehensive
- 20 strategic plan to prevent and end homelessness.
- 21 "Opening Doors" identified the following four ambitious
- 22 goals of finishing the job of ending chronic homelessness in

- 1 five years; preventing and ending homelessness among veterans in
- 2 five years; preventing and ending homelessness for families,
- 3 youth, and children in ten years; and setting a path to ending
- 4 all types of homelessness.
- 5 The governor of Hawaii has found it to be imperative and in
- 6 the public interest to capitalize on the opportunities and
- 7 momentum generated by the United States Interagency Council on
- 8 Homelessness, to provide leadership for the prevention and
- 9 elimination of homelessness, and to keep Hawaii at the forefront
- 10 of providing care to its residents in the spirit of the Law of
- 11 the Splintered Paddle (Ke Kānāwai Mamalahoe), Hawaii State
- 12 Constitution, Article IX, Section 10.
- 13 Consequently, on July 19, 2011, Governor Neil Abercrombie,
- 14 through the issuance of Executive Order No. 11-21, pursuant to
- 15 the provisions of section 26-41, Hawaii Revised Statutes,
- 16 temporarily established the Hawaii interagency council on
- 17 homelessness.
- 18 The purpose of this Act is to establish the Hawaii
- 19 interagency council on homelessness by statute, which will
- 20 further enhance the ability of the council to provide solutions
- 21 for ending homelessness in Hawaii. By establishing the
- 22 interagency council on homelessness by statute the importance of

2 administrations is strengthened. 3 SECTION 2. Chapter 346, Hawaii Revised Statutes, is 4 amended by adding a new part to be appropriately designated and 5 to read as follows: 6 "PART . HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS 7 Hawaii interagency council on homelessness; §346-8 establishment. There is established the Hawaii interagency 9 council on homelessness, which shall be an advisory body exempt 10 from section 26-34, Hawaii Revised Statutes. The Hawaii 11 interagency council on homelessness shall be placed within the 12 department of human services for administrative purposes. 13 The Hawaii interagency council on homelessness shall: 14 (1) Serve as the statewide homelessness planning and 15 policy development entity with broad representation 16 from state and county government and the community; **17** (2) Formulate and advise the governor on the 18 implementation of a unified ten-year, statewide plan 19 to address homelessness in all Hawaii counties; 20 (3) Facilitate the acquisition of funding and resources 21 for state and county homeless programs;

The Hawaii Interagency Council on §346-17 Homelessness shall meet quarterly, or more frequently as it 18 deems necessary. 19 A majority of the members of the Hawaii interagency council 20 on homelessness shall constitute a quorum to do business and to 21 validate any decision or act of the council."

1	SECTION 3. There is appropriated out of the general			
2	revenues of the State of Hawaii the sum of \$ , or so			
3	much thereof as may be necessary for fiscal year 2012-2013, for			
4	administrative expenses of the Hawaii interagency council on			
5	homelessness.			
6	The sums appropriated shall be expended by the department			
7	of human services for the purposes of this Act.			
8	SECTION 4. This Act shall take effect on July 1, 2012;			
9	provided that on June 30, 2022, this Act shall be repealed.

TITLE:

A BILL FOR AN ACT RELATING TO THE HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS.

PURPOSE:

To establish the Hawaii Interagency Council on Homelessness and to make an appropriation for its administrative expenses.

MEANS:

Add a new part to chapter 346, Hawaii Revised Statutes.

JUSTIFICATION:

Homelessness is a complex and multifaceted issue requiring planning, coordination, implementation, and funding across Federal, State, local, business and community lines. Locally, many government agencies, non-profits, and the private sector have worked diligently and successfully to assist those who are homeless. Yet, Hawaii has experienced an increase in the number of homeless individuals and families.

On July 19, 2011, Governor Neil Abercrombie, through the issuance of Executive Order No. 11-21, pursuant to the provisions of section 26-41, Hawaii Revised Statutes, temporarily established the Hawaii Interagency Council on Homelessness (HICH). In establishing the HICH, the Governor of Hawaii found it to be imperative and in the public interest to capitalize on the opportunities and momentum generated by the United States Interagency Council on Homelessness by providing leadership for the prevention and elimination of homelessness, and to keep Hawaii at the forefront of providing care to its residents in the spirit of the Law of the Splintered Paddle (Ke Kānāwai Mamalahoe).

Establishing the HICH by statute will enhance the ability of the council to provide solutions for ending homelessness in Hawaii by highlighting the importance on ending homelessness and strengthening continuity through administrations.

Impact on the public: A high level of coordinated community action to end homelessness in Hawaii is established with the objective of ending homelessness in ten years.

Impact on the department and other agencies: Fosters more efficient use of limited funds via planning and interagency coordination.

GENERAL FUND:

OTHER FUNDS:

Currently funded by \$116,500 in grant moneys which will expire May 31, 2012. Unexpended funds may be carried over into the next grant period beginning June 1, 2012.
