## A BILL FOR AN ACT

RELATING TO MORTALITY REVIEW OF DEATHS OF PERSONS WITH DEVELOPMENTAL OR INTELLECTUAL DISABILITIES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 321, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . MORTALITY REVIEW OF DEATHS OF PERSONS WITH
- 5 DEVELOPMENTAL OR INTELLECTUAL DISABILITIES
- 6 §321- Multidisciplinary and multiagency mortality
- 7 reviews. The department may conduct multidisciplinary and
- 8 multiagency mortality reviews of deaths of persons with
- 9 developmental or intellectual disabilities in order to reduce
- 10 the incidence of preventable deaths to persons with
- 11 developmental or intellectual disabilities.
- 12 §321- Definitions. As used in this part:
- "Adult" means a person eighteen years of age or older.
- 14 "Adult death review information" means information
- 15 regarding the adult person and person's family, including but
- 16 not limited to:
- 17 (1) Social, medical, and legal histories;

1 care, treatment, or other services which are of 2 lifelong or extended duration and are individually 3 planned and coordinated. 4 "Director" means the director of health or the director's 5 designated representative. 6 "Disabled person" means an adult with a developmental or 7 intellectual disability. 8 "Intellectual Disability" means significantly sub-average 9 general intellectual functioning resulting in or associated with 10 concurrent moderate, severe, or profound impairments in adaptive 11 behavior and manifested during the developmental period. 12 "Preventable death" means a death that reasonable medical, 13 social, legal, psychological, or educational intervention may 14 have prevented. 15 "Provider of medical care" means any health care 16 practitioner who provides, or a facility through which is provided, any medical evaluation or treatment, including dental **17** 18 and mental health evaluation or treatment. 19 §321-Access to information. (a) Upon written request 20 by the director, all providers of medical care or other services 21 and state and county agencies shall disclose to the department

and those individuals appointed by the director to participate

- 3 information regarding the circumstances of a death of a person
- 4 with developmental or intellectual disabilities so that the
- 5 department may conduct multidisciplinary and multiagency

- 7 intellectual disabilities pursuant to section 321-31 and this
- 8 part.
- 9 (b) To the extent that this section conflicts with other
- 10 state confidentiality laws, this section shall prevail.
- 11 §321- Exception. Information regarding an ongoing civil
- 12 or criminal investigation shall be disclosed at the discretion
- 13 of the applicable state, county, or federal law enforcement
- 14 agency.
- 15 §321- Use of information and records from mortality
- 16 reviews of deaths of persons with developmental or intellectual
- 17 disabilities. (a) Except as otherwise provided in this part,
- 18 all information and records acquired by the department during
- 19 its multidisciplinary and multiagency mortality reviews of
- 20 deaths of persons with developmental or intellectual
- 21 disabilities pursuant to this part is confidential and may be

- 1 disclosed only as necessary to carry out the purposes of this
- 2 part.
- 3 (b) Information and statistical compilations of data from
- 4 the multidisciplinary and multiagency mortality reviews of
- 5 deaths of persons with developmental or intellectual
- 6 disabilities that do not contain any information that would
- 7 permit the identification of any person shall be public records.
- 8 (c) No individual participating in the department's
- 9 multidisciplinary and multiagency mortality review of a death of
- 10 a person with developmental or intellectual disabilities may be
- 11 questioned in any civil or criminal proceeding regarding
- 12 information presented in or opinions formed as a result of a
- 13 meeting of the multidisciplinary and multiagency mortality
- 14 review of deaths of persons with developmental or intellectual
- 15 disabilities. Nothing in this subsection shall be construed to
- 16 prevent a person from testifying to information obtained
- 17 independently of the department's multidisciplinary and
- 18 multiagency mortality review of deaths of persons with
- 19 developmental or intellectual disabilities, or which is public
- 20 information, or where disclosure is required by law or court
- 21 order.

- 1 (d) Information held by the department as a result of a
- 2 multidisciplinary and multiagency mortality review of a death of
- 3 a person with developmental or intellectual disabilities
- 4 conducted under this part shall not be subject to subpoena,
- 5 discovery, or introduction into evidence in any civil or
- 6 criminal proceeding, except that information otherwise available
- 7 from other sources is not immune from subpoena, discovery, or
- 8 introduction into evidence through those sources solely because
- 9 they were provided as required by this part.
- 10 §321- Immunity from liability. All agencies and
- 11 individuals participating in multidisciplinary and multiagency
- 12 mortality reviews of deaths of persons with developmental or
- 13 intellectual disabilities pursuant to this part shall not be
- 14 held civilly or criminally liable for providing the information
- 15 required under this part."
- 16 SECTION 2. This Act shall take effect upon its approval.
