A BILL FOR AN ACT

RELATING TO THE HAWAII EARLY INTERVENTION COORDINATING COUNCIL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 321-353, Hawaii Revised Statutes, is

TITLE:

A BILL FOR AN ACT RELATING TO THE HAWAII EARLY INTERVENTION COORDINATING COUNCIL.

PURPOSE:

To revise the membership and functions of the Hawaii Early Intervention Coordinating Council (HEICC) to meet the requirements for the State interagency coordinating council set forth in part C of the Individuals with Disabilities Education Act of 2004 (P.L. 108-446, Section 641), codified at 20 U.S.C. § 1441 (referred to as "Part C of IDEA").

MEANS:

Amend section 321-353, Hawaii Revised Statutes.

JUSTIFICATION:

The Department of Health (DOH) receives over \$2.1 million in federal funds annually, which support services to infants and toddlers with disabilities ("early intervention services"). Part C of IDEA specifies the composition and functions of the required State interagency coordinating council.

The HEICC was established by section 321-353 in 1989, as required by the federal Education of the Handicapped Act Amendments of 1986, which preceded Part C of IDEA.

Compliance with current federal requirements for the council requires the specification of additional HEICC members, members not voting when there is the appearance of conflict of interest, prohibition of a member from the department of health serving as the HEICC chairperson, and an additional function of advising and assisting the State educational agency regarding the transition of toddlers with special needs and their families.

Impact on the public: The broader HEICC membership will help to ensure the provision and coordination of EI services to meet the needs of infants and toddlers with special needs and their families.

Impact on the department and other agencies: DOH will be designated a member of the HEICC and will participate in HEICC policy planning and decisions related to DOH EI services.

Members of the public and state/community agencies will have a clear description of the required HEICC composition.
