A BILL FOR AN ACT

RELATING TO VESSELS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 200-41, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"[+]§200-41[+] Disposition [by chairperson] of certain
4	abandoned vessels. (a) Any vessel [which:
5	(1) Has been left unattended for a continuous period of
6	more than thirty days; and
7	(2) Is within the waters of the State or on public
8	property, or is on private property without
9	authorization of the owner or occupant of the
10	property,
11	may be caused by the chairperson to be taken into custody and
12	disposed of pursuant to this part. may be deemed abandoned if
13	the vessel has been moored or otherwise left in the waters of
14	the State or on public property contrary to law or rules having
15	the force and effect of law, or left on private property without
16	authorization of the owner or occupant of the property if:
17	(1) The vessel's registration certificate or marine
18	document has expired and the registered owner no

1		longer resides at the address listed in the vessel
2		registration or marine document records of the
3		department or the United States Coast Guard;
4	(2)	The last registered owner of record disclaims
5		ownership and the current owner's name or address
6		cannot be determined;
7	(3)	The vessel identification numbers and other means of
8		identification have been removed so as to hinder or
. 9		nullify efforts to locate or identify the owner;
10	(4)	The vessel registration records of the department of
11		land and natural resources and the marine document
12		records of the United States Coast Guard contain no
13		record that the vessel has ever been registered or
14		documented and the owner's name or address cannot be
15		determined; or
16	(5)	The requirements of section 200-52 are met.
17	<u>(b)</u>	The determination whether a vessel is abandoned may be
18	made by:	
19	(1)	The chairperson, with regard to public property under
20		the jurisdiction of the department of land and natural
21		resources; or

T	(2)	Any other state department or agency through its
2		director, with regard to public property within the
3		department or agency's respective jurisdiction; or
4	<u>(3)</u>	Any county through its mayor or the mayor's designee,
5	•	or chief of police, with regard to public property
6		within the respective county's jurisdiction; provided
7		that the department shall provide to the respective
8		county access to the department's vessel registration
9		and marine document records or those of the United
10		States Coast Guard for the purposes of this section.
11	Once a ve	ssel is deemed abandoned, the appropriate official
12	under thi	s subsection may direct and cause the vessel to be
13	taken int	o custody and disposed of pursuant to and in the manner
14	provided	in this chapter.
15	<u>(c)</u>	All vessels abandoned on private property shall be the
16	responsib	ility of the private property owner."
17	SECT	ION 2. Section 200-42, Hawaii Revised Statutes, is
18	amended t	o read as follows:
19	"§20	0-42 Notice to owner. [Upon] A state or county
20	agency, u	pon taking custody of any vessel, [a written notice]
21	shall imm	ediately [be posted] post a written notice on the
22	vessel and	d <u>send</u> a duplicate original [sent] by registered or

- 2 owner registered with the department or documented by the United
- 3 States Coast Guard or any lien holder or operator of the vessel

- 6 department or the United States Coast Guard. The notice shall
- 7 contain a brief description of the vessel, the location of
- 8 custody, and the intended disposition of the vessel if not
- 9 repossessed within twenty days after the mailing of the notice.
- 10 Such owner, lien holder, or operator, of the vessel shall have
- 11 ten days after receipt of the mailed notice to request in
- 12 writing an administrative hearing[-] pursuant to chapter 91 from
- 13 the state or county agency that took custody of the vessel.
- 14 This administrative hearing is solely for the purpose of
- 15 allowing the owner, lien holder, or operator of an impounded
- 16 vessel to contest the basis given [by the department] for the
- 17 impoundment of the vessel. The hearing [must] shall be held
- 18 within five working days of the [department's] state or county
- 19 agency's receipt of the written request."
- 20 SECTION 3. Section 200-44, Hawaii Revised Statutes, is
- 21 amended to read as follows:

- 1 "§200-44 Possession by interested party. Any person 2 having an interest in the vessel taken into custody may take 3 possession of the vessel prior to the date of public auction 4 upon payment to the [department] state or county agency that 5 took custody of the vessel of all use fees, towing, handling and 6 storage charges, appraisal and advertising expenses, and any 7 other expenses incurred by [the department] that state or county 8 agency in connection with the vessel. If the person taking possession of the vessel is not the registered or documented 9 10 owner, the person, prior to taking possession of the vessel, 11 shall pay the foregoing expenses and post security satisfactory 12 to the [department] state or county agency, which shall not 13 exceed the value of the vessel. The security, if not forfeited, 14 shall be returned to the person posting it within two years 15 after receipt." SECTION 4. Section 200-45, Hawaii Revised Statutes, is 16 17 amended to read as follows:
- "\$200-45 When public auction not required. Public auction
 shall not be required when the appraised value of any vessel is
 less than \$5,000, as determined by an independent appraiser who
 has at least one year of experience in the sale or purchase of
 vessels. Upon that determination, after public notice of

- 2 [department] state or county agency that took custody of the
- 3 vessel may sell the vessel by negotiation, dispose of it as
- 4 junk, or donate the vessel to any governmental agency."
- 5 SECTION 5. Section 200-46, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "[+] \$200-46[+] Effect of sale. The transfer of interest
- 8 by sale hereunder shall be evidenced by a bill of sale from the
- 9 [department,] appropriate state or county agency, shall be
- 10 considered a transfer by operation of law, and shall be governed
- 11 by provisions applicable thereto.
- 12 SECTION 6. Section 200-47, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§200-47 Disposition of proceeds. [The department] A
- 15 state or county agency that sells a vessel pursuant to this part
- 16 shall deposit that portion of the proceeds of the sale of [a]
- 17 the vessel that represents the mooring or other fees and charges
- 18 due the [department] agency, the expenses of the auction, and
- 19 any other expense incurred by the [department] agency in taking
- 20 into custody and disposing of an abandoned vessel, derelict
- 21 vessel, or vessel impounded under section 200-16, into the
- 22 boating special fund or other state or county fund, as

    appropriate, from which the expenses incurred in connection with
2
    the vessel were paid. The balance, if any, shall be deposited
3
    into the general fund of the State. The owner may recover any
4
    balance of the proceeds from the State only if the owner files a
5
    claim therefor with the department of budget and finance within

    one year after the execution of the bill of sale. If no claim
7
    is made within the year allowed, the money shall become a state
8
    realization. A lien holder shall receive priority in payment

    from the balance of the proceeds to the extent of the lien

8	abandons a vessel upon the premises of a vessel repair business,
9	a private marina, [ex] a yacht club, or other private property,
10	the owner of the vessel repair business or private marina, or
11	the owner's representative[, or]; the designated representative
12	of the yacht $club[\tau]$; or the owner of other private property,
13	may sell or dispose of the vessel in [accord] accordance with
14	this part."
15	SECTION 9. Section 200-52, Hawaii Revised Statutes, is
16	amended by amending its title to read as follows:
17	"\$200-52 When vessel deemed abandoned[-] on the premises
18	of a vessel repair business, private marina, or yacht club.
19	SECTION 10. Section 200-53, Hawaii Revised Statutes, is

21	"§200-53 Sale or disposition of vessel. When a vessel is
22	abandoned, the owner of the vessel repair business $[-,]$ or private

- 2 designated representative of the yacht club $[\tau]$; or the owner of
- 3 other private property, after one public advertisement in a

- 6 shall not be sold or disposed of less than five calendar days
- 7 after the publication of the advertisement. Upon the sale or
- 8 disposal of the vessel under this part, the owner of the vessel
- 9 repair business $[\tau]$ or private marina, or the owner's authorized
- 10 representative[, or]; the designated representative of the yacht
- 11 club[7]; or the owner of other private property, shall file an
- 12 affidavit with the department stating to whom the vessel was
