## A BILL FOR AN ACT

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Taxpayers are required to obtain tax clearances
2	from the department of taxation for various purposes, including
3	obtaining a government contract or receiving final payment on a
4	government contract. Currently, taxpayers may obtain tax
5	clearances without paying a fee for the tax clearance. The
6	department of taxation processes approximately 20,000 to 30,000
7	tax clearance requests per year. In addition, certified copies
8	of the tax clearance can also be obtained from the department of
9	taxation without paying a fee. Approximately, 30,000 certified
10	copies of tax clearances are provided each year. This Act would
11	impose a \$20 fee on taxpayers to request a tax clearance and a
12	\$5 fee to obtain a certified copy of a tax clearance.
13	SECTION 2. Chapter 231, Hawaii Revised Statutes, is
14	amended by adding a new section to be appropriately designated
15	and to read as follows:
16	"§231- Tax clearance fees. The department may charge a
17	fee of \$20 for each tax clearance application submitted by a
10	taxpayor and de for each contified convert of a tax clearance

1	issued to a taxpayer. The department may charge additional fees
2	related to the issuance of tax clearances."
3	SECTION 3. New statutory material is underscored.
4	SECTION 4. This Act shall take effect upon its approval
5	and shall apply to requests for tax clearances and requests for
6	certified copies of tax clearances received on or after July 1,
7	2012.
