## A BILL FOR AN ACT

RELATING TO DRIVER LICENSING.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 286, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated

4	"§286- Driver's license reciprocity committee. (a)
5	The director shall establish a statewide driver's license
6	reciprocity committee consisting of one representative from the
7	department of transportation and each of the four county chief

9	convene whenever a foreign country makes a request for driver's
10	license reciprocity.
11	(b) The statewide driver's license reciprocity committee
12	shall evaluate the written knowledge and practical examination
13	program of the requesting foreign country for driver's license

15	(c) Members of the statewide driver's license reciprocity
16	committee shall serve voluntarily and without compensation, but

The costs shall be paid by the department of 2 transportation. 3 (d) In the event there is available from the requesting 4 foreign country an evaluation prepared by another United States 5 driver licensing agency or the American Association of Motor 6 Vehicle Administrators, then the statewide driver's license 7 reciprocity committee shall conduct a comparison review of the 8 evaluation and the State's driver licensing examination 9 standards and submit a written recommendation to the legislature 10 no later than twenty days prior to the convening of the 11 appropriate legislative session. 12 (e) If there is no such evaluation available from the 13 requesting foreign country, then the director of transportation 14 may select from the statewide driver's license reciprocity 15 committee a representative from the department of transportation 16 and a representative from the counties' examiner of drivers to 17 travel to the requesting foreign country, at the expense of the requesting foreign country, to inspect and examine the foreign 18 19 country's driver's license examination program and advise the committee of their findings.
