A BILL FOR AN ACT

RELATING TO TOURISM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 237D, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§237D- Donation; department of land and natural
- 5 resources. (a) Each operator and plan manager shall inform
- 6 each occupant of a transient accommodation of the option to
- 7 donate \$1 to the department of land and natural resources. The
- 8 department of land and natural resources shall prepare and
- 9 distribute to all operators and plan managers information that
- 10 may be distributed to each occupant of a transient accommodation
- 11 regarding the use of the donated funds.
- 12 (b) Each operator and plan manager shall remit the amount
- 13 of the donations collected under subsection (a) to the
- 14 department on the twentieth day of each month following the
- 15 month in which the donation was collected and shall remit the
- 16 amount by cash, bank draft, cashier's check, money order, or
- 17 certificate of deposit.

1	<u>(c)</u>	The director of taxation shall credit funds remitted
2	pursuant to this section to the state parks special fund	
3	established by section 184-3.4."	
4	SECT	ION 2. Section 184-3.4, Hawaii Revised Statutes, is
5	amended by amending subsection (a) to read as follows:	
6	"(a)	There is established within the state treasury a fund
7	to be known as the state parks special fund, into which shall be	
8	deposited:	
9	(1)	All proceeds collected by the state parks programs
10		involving park user fees, any leases or concession
11		agreements, the sale of any article purchased from the
12		department to benefit the state parks programs, or any
13		gifts or contributions; provided that proceeds derived
14		from the operation of Iolani Palace shall be used to
15		supplement its educational and interpretive programs;
16		[and]
17	(2)	Transient accommodations tax revenues pursuant to
18		section 237D-6.5; provided that these moneys shall be
19		expended in response to a master plan developed in
20		coordination with the Hawaii tourism authority[+]; and
21	(3)	Donations collected pursuant to section 237D"

- 1 SECTION 3. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 4. This Act shall take effect upon its approval.
