A BILL FOR AN ACT

RELATING TO ALLOWING DOGS IN RESTAURANTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 321, Hawaii Revised Statutes, is	
2	amended by adding a new section to be appropriately designated		
3	and to read as follows:		
4	" <u>§321</u>	Dogs allowed in restaurants. (a)	
5	Notwithsta	anding any law or rule to the contrary, except as	
6	provided i	in subsections (g) and (h), at the discretion of the	
7	owner or n	manager of a restaurant, a restaurant patron may bring	
8	a dog into	the restaurant under the following conditions:	
9	<u>(1)</u>	The dog shall be under the control of the patron at	
10		all times, on a leash that is tied or fastened to keep	
11		the dog within two feet of the patron;	
12	(2)	The dog shall remain at the patron's seating area and	
13		on the floor;	
14	(3)	The dog shall not interfere with the activities of the	
15		restaurant's employees, shall not obstruct any	
16		pathways, and shall not enter food preparation areas;	

1	(4)	The dog shall not relieve itself within the
2		restaurant, bark, or otherwise disturb other patrons;
3		and
. 4	(5)	The dog and patron shall abide by any other conditions
5		that the owner or manager of the restaurant may
6		impose.
7	(b)	A restaurant that permits dogs in the restaurant shall
8	have safe	ty and sanitation control procedures in effect to:
9	(1)	Immediately clean any animal feces, urine, waste,
10		saliva, vomitus, or other animal fluids, and properly
11		disinfect contaminated areas and surfaces; and
12	(2)	Prevent animal waste from entering food preparation
13		areas.
14	(c)	A restaurant that permits dogs in the restaurant shall
15	post prom	inently at each entrance a sign displaying the message,
16	"Dogs are	allowed in this restaurant." The restaurant shall
17	post adja	cent to that sign a list of all conditions contained in
18	subsection	n (a) and a clear description of any additional
19	conditions	s imposed on dogs present in the establishment by the
20	owner or manager of the restaurant.	

- 1 (d) If any of the conditions in subsection (a) are not
- 2 met, the owner or manager of the restaurant may require the
- 3 patron to remove the dog from the restaurant.
- 4 (e) The restaurant patron who brings a dog into the
- 5 restaurant, and the dog's owner if the owner is not the patron,
- 6 shall be liable for any and all property damage and personal
- 7 injury that the dog may cause while in the restaurant.
- 8 (f) For purposes of this section, the term "restaurant"
- 9 means any place where food is served or provided to the public
- 10 at a charge, including outdoor seating areas, regardless of
- 11 whether the food is consumed on or off the premises.
- 12 (g) If any provisions of this section conflict with
- 13 federal law governing service animals, the federal law shall
- 14 prevail.
- 15 (h) Nothing in this section shall diminish the rights of
- 16 persons with disabilities to request and obtain reasonable
- 17 accommodations under chapter 489."
- 18 SECTION 2. New statutory material is underscored.
- 19 SECTION 3. This Act shall take effect upon its approval.
