# A BILL FOR AN ACT

RELATING TO BROADBAND.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 201, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated	
3	and to read as follows:	
4	" <u>§20</u>	1- Broadband special fund. (a) There is
5	<u>establish</u>	ed in the state treasury the broadband special fund
6	into which shall be deposited:	
7	(1)	Moneys deposited pursuant to Act , Session Laws of
8		<u>Hawaii 2012;</u>
9	(2)	Appropriations from the legislature;
10	<u>(3)</u>	All accrued interest from the fund; and
11	(4)	Contributions, grants, endowments, or gifts in cash
12		received by the fund.
13	(b)	Moneys in the broadband special fund shall be expended
14	by the de	partment of business, economic development, and tourism
15	to suppor	t an initiative that provides:
16	(1)	Broadband access to public schools; and
17	(2)	The means necessary for technology-based learning in
18		public schools, including but not limited to the

1	provision of laptop computers to public school		
2	students.		
3	For purposes of this subsection, "laptop computers" means		
4	portable computer devices.		
5	(c) The broadband special fund may receive contributions,		
6	grants, endowments, or gifts in cash or otherwise from all		
7	sources including corporations or other businesses, foundations,		
8	government, individuals, and other interested parties.		
9	Notwithstanding any provision of law to the contrary, as a		
10	condition of a gift to the broadband special fund, a donor may		
11	specify a particular county in which the donor's gift shall be		
12	used or expended for the purposes listed in subsection (b).		
13	(d) The State may appropriate moneys to the special fund;		
14	provided that any appropriations made by the State are not		
15	intended to supplant the funding of any existing public school		
16	program.		
17	(e) All unexpended and unencumbered moneys remaining on		
18	balance with the broadband special fund on June 30, 2017, shall		
19	lapse to the credit of the state general fund."		
20	SECTION 2. (a) Notwithstanding any law to the contrary,		
21	beginning January 1, 2013, and in each year thereafter, all		
22	recipients of moneys appropriated from fees collected pursuant

- 1 to chapter 440G, Hawaii Revised Statutes, shall receive no more
- 2 in annual appropriations than the lesser of:
- 3 (1) The amount that the recipient received in 2011 that
- 4 was calculated based upon revenue generated by a cable
- 5 operator in 2010; or
- 6 (2) The amount that the recipient would otherwise be
- 7 calculated to receive in that current year based upon
- 8 revenue generated by a cable operator in the previous

- 18 SECTION 4. This Act shall take effect on July 1, 2012, and
- 19 shall be repealed on June 30, 2017.

### Report Title:

Broadband; Cable Television Systems; Special Fund

### Description:

Creates the broadband special fund to support funding public school broadband and laptop initiatives. Freezes appropriations of moneys derived from cable fees at the lesser of the 2011 appropriation or the amount that a recipient would otherwise receive in the current year. Requires excess moneys to be deposited into the broadband special fund. Effective July 1, 2012, and repealed June 30, 2017. (HB2874 HD1)
