A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. The legislature finds that organ
- 5 transplantation is a life-saving therapy for many critically ill
- 6 patients with end-stage diseases. More than one hundred ten
- 7 thousand patients are on the national organ transplant waiting
- 8 list; four hundred seven of those patients are Hawaii residents.
- 9 The legislature further finds that there is only one Centers for
- 10 Medicare and Medicaid Services-certified organ transplant
- 11 facility for liver and kidney transplants in the State, where
- 12 dozens of transplantations are performed each year and patients
- 13 with organ transplants continue to receive monitoring and
- 14 follow-up care from medical staff, physicians, and surgeons
- 15 after their operations.
- 16 Funding is critical to maintain a federally-recognized
- 17 stage 3 chronic kidney disease program that focuses on

- 1 prevention for disparate populations in Hawaii. Without
- 2 operational organ transplant services in the State, patients
- 3 with end-stage diseases must register on transplant waiting
- 4 lists for mainland transplant centers and many of these patients
- 5 will face a longer waiting time to receive a donor organ at a
- 6 transplant center on the mainland than at a transplant center in
- 7 Hawaii. The increased waiting time for an organ may mean that
- 8 the sickest of those patients may not survive long enough for a
- 9 donor organ to become available. In addition to the increased
- 10 waiting time, many waitlisted patients in the State will have
- 11 the additional burden of relocating to other areas of the
- 12 country, away from friends and family, while awaiting a donor
- 13 organ and during their recovery.
- 14 An emergency appropriation is necessary to preserve and
- 15 save the lives of individuals combating organ failure by
- 16 providing them with access to organ transplantation in the State
- 17 and giving them quality care and treatment throughout their
- 18 operation and recovery.
- 19 The purpose of this Act is to appropriate emergency funds,
- 20 subject to dollar-for-dollar private matching funds, to support
- 21 ongoing services by a qualified provider with United Network for
- 22 Organ Sharing certification to perform kidney and liver

- 1 transplants in Hawaii, and to support a federally-recognized
- 2 chronic kidney disease management program.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$1,800,000 or so much
- 5 thereof as may be necessary for fiscal year 2011-2012 to support
- 6 ongoing services by a qualified provider with United Network for
- 7 Organ Sharing certification to perform kidney and liver
- 8 transplants in Hawaii and to support a federally-recognized
- 9 chronic kidney disease management program; provided that:
- 10 (1) No funds appropriated under this Act shall be expended
- unless matched dollar-for-dollar with private funds;
- **12** and
- 13 (2) Any private matching funds obtained for the purposes
- of this Act shall have priority in being encumbered
- over public funds.
- 16 The sum appropriated shall be expended by the department of
- 17 health for the purposes of this Act.
- 18 SECTION 4. Funds appropriated under this Act shall be
- 19 exempt from chapter 42F, Hawaii Revised Statutes.
- 20 SECTION 5. This Act shall take effect upon its approval

Description:

Appropriates emergency funds, subject to dollar-for-dollar private matching funds, to be expended by the Department of Health to support ongoing services provided by a qualified provider with United Network for Organ Sharing certification to perform kidney and liver transplants in Hawaii and to support a federally-recognized chronic kidney disease management program, subject to certain conditions.
