# A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a shortage
- 2 of long-term care beds in many areas of the State, including
- 3 Oahu. This shortage has placed an undue burden on acute care
- 4 hospitals that are experiencing a long list of patients who are
- 5 awaiting placement in a long-term care bed. The waitlist
- 6 problem presents quality of care issues for both patients who
- 7 are awaiting long-term care beds and patients who need acute
- 8 care beds.
- 9 The closing of Hawaii Medical Center further exacerbated
- 10 the shortage problem by eliminating a large number of long-term
- 11 care beds that had been available, along with the elimination of
- 12 other needed services. Furthermore, the number and types of
- 13 beds eliminated by the closing of Hawaii Medical Center cannot
- 14 be fully absorbed by existing facilities.
- 15 Hawaii health systems corporation, the fourth largest
- 16 public hospital system in the nation, operates public health
- 17 care facilities that provide essential safety-net hospital and
- 18 long-term care services throughout the State. The legislature



- 1 further finds that Leahi hospital, a facility of the Hawaii
- 2 health systems corporation, can help alleviate the shortage of
- 3 long-term care beds, but needs major renovation.
- 4 Accordingly, the legislature finds that it is in the public
- 5 interest to establish a public-private partnership between the
- 6 owners of the facility previously known as Hawaii Medical
- 7 Center-East, located on Liliha Street in Honolulu, and the
- 8 Hawaii health systems corporation, to provide long-term care and
- 9 other health care services in the State.
- 10 The purpose of this Act is to provide for the health care
- 11 needs of the community by authorizing the Hawaii health systems
- 12 corporation to bring the Hawaii Medical Center-East facility
- 13 under its governance through formal affiliation or acquisition.
- 14 SECTION 2. Chapter 323F, Hawaii Revised Statutes, is
- 15 amended by adding a new section to part III to be appropriately
- 16 designated and to read as follows:
- 17 "§323F- Hawaii Medical Center-East; affiliation;
- 18 acquisition. (a) The Hawaii Medical Center-East on Oahu may be
- 19 assimilated into the Hawaii health systems corporation by
- 20 negotiation between the corporation and the owners of the Hawaii
- 21 Medical Center-East. Assimilation may be accomplished with the
- 22 creation of a new entity, a partnership, a long-term lease, or



- 1 any other vehicle determined to be in the best interests of the
- 2 public by the corporation board and as negotiated with the
- 3 owners of the Hawaii Medical Center-East. After assimilation,
- 4 Hawaii Medical Center-East shall be operated by the corporation,
- 5 either directly, through contractors, or through a subsidiary.
- 6 (b) None of the liabilities of Hawaii Medical Center-East
- 7 shall become liabilities of the corporation.
- 8 (c) The Hawaii Medical Center-East, once assimilated,
- 9 shall be exempt from chapter 102 and section 103-53, and its
- 10 board of directors, if any, shall be exempt from part I of
- 11 chapter 92.
- 12 (d) The purchase of goods and services by or on behalf of
- 13 Hawaii Medical Center-East, after assimilation, shall be exempt
- 14 from chapters 103D and 103F.
- 15 (e) Assimilation of Hawaii Medical Center-East into the
- 16 Hawaii health systems corporation shall be exempt from part VII
- 17 of chapter 323D."
- 18 SECTION 3. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so much
- 20 thereof as may be necessary for fiscal year 2012-2013 to carry
- 21 out the purposes of this Act, including the hiring or
- 22 contracting of staff.
