## A BILL FOR AN ACT

RELATING TO PLANNED COMMUNITY ASSOCIATIONS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that there has been		
2	on-going dispute in planned community associations between		
3	members and association boards regarding the right of members to		
4	display the flag of the United States and the flag of the State		
5	of Hawaii. In addition, there has been public outcry from		
6	members of planned community associations who wish to display		
7	these flags but have been prevented from doing so by association		
8	boards through denials, fines, and the imposition of large fees		
9	The purpose of this Act is to clarify the right of members		
10	of planned community associations to display the United States		
11	and State of Hawaii flags on their properties.		
12	SECTION 2. Chapter 421J, Hawaii Revised Statutes, is		
13	amended by adding a new section to be appropriately designated		
14	and to read as follows:		
15	"§421J- Display of house-mounted United States and

13	<u>(c)</u>	Flags displayed pursuant to this section shall be	
14	displayed	in a prominent position on the residential dwelling;

16	(1)	United States flags shall be displayed in accordance	
17		with the provisions of title 4 United States Code	
18		chapter 1; and	
19	(2)	State of Hawaii flags shall be displayed in accordance	
20		with section 5-19 and consistent with the treatment of	

the United States flag under title 4 United States

Code section 8.

## Report Title:

Planned Community Associations; United States Flag; State of Hawaii Flag; Display

## Description:

Prohibits planned community associations and their boards of directors from: (1) Disallowing a member or their bona fide tenant from displaying house-mounted United States or State of Hawaii flags on their residential dwelling; and (2) Assessing or charging any fee or fine, or imposing any penalty, on their members, for house-mounted display of these flags. Requires the flags to be displayed in a prominent position on the residential dwelling. Effective January 7, 2059. (HB69 HD2)
