A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that certain companies
- 2 require local farmers to have third-party food safety
- 3 certifications before purchasing locally grown food from those
- 4 farmers. The legislature further finds that private food safety
- 5 certification is often cost prohibitive and places a financial
- 6 burden on local farmers. Farmers who cannot afford third-party
- 7 food safety certifications will miss out on market opportunities
- 8 to sell their products.
- 9 The purpose of this Act is to require the department of
- 10 agriculture to develop a food safety compliance certificate
- 11 program that allows farmers to obtain a certificate that is
- 12 equivalent to a third-party food safety certification.
- 13 SECTION 2. Chapter 141, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "\$141- Food safety compliance certificate program. (a)
- 17 The department of agriculture shall issue a food safety
- 18 compliance certificate to any farmer who registers with the

5	(2)	Identification of the primary crops grown by the

9		animal pathogens, including records of how food is
10		grown, handled, and stored;
11	(4)	Any other information that may assist the department
12		with:
13		(A) Compiling accurate information on the food safety
14		practices of farmers in the State;
15		(B) Tracing specific food-borne pathogen outbreaks
16		related to locally grown crops; and
17		(C) Developing methods of preventing food-borne
18		pathogen outbreaks from reoccurring.
19	(b)	A food safety compliance certificate issued pursuant
20	to this s	ection shall be equivalent to any food safety
21	certifica	tion issued by a private third party.

1	(c) The department shall keep registration information		
2	confidential to the extent that the information falls within an		
3	exception to disclosure under chapter 92F; provided that the		
4	name, business address, and primary crops of each registrant		
5	shall be made publicly available by the department; provided		
6	further that the department may compile statistics based on the		
7	information, pursuant to section 141-1.		
8	(d) The department shall charge a fee of \$100 for		
9	registration under this section.		
10	(e) A food safety compliance certificate shall be		
11	effective for a period of one year, and may be renewed at the		
12	end of each one-year period.		
13	(f) The department may adopt rules pursuant to chapter 91		
14	to carry out the purpose of this section."
