RELATING TO HEALTH.

	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that all residents of
2	Hawaii should have access to health care in all its facets,
3	including affordable access to prescription drugs. The public
4	relies heavily on health insurance policies to provide adequate
5	medical care. However, current policies do not require insurers
6	to cover outpatient prescription drugs, nor do they impose
7	coverage requirements on insurers that do provide outpatient
8	prescription drug coverage.
9	The purpose of this Act is to make outpatient prescription
10	drugs more affordable and accessible to the residents of Hawaii.
11	SECTION 2. Chapter 431:10A, Hawaii Revised Statutes, is
12	amended by adding a new section to be appropriately designated
