A BILL FOR AN ACT

RELATING TO THE PRESERVATION OF HAWAII'S MOVING IMAGES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that 'Ulu'ulu: The Henry
- 2 Ku'ualoha Giugni Moving Image Archive of Hawai'i, honors the
- 3 former United States Senate Sergeant at Arms. Henry Giugni was
- 4 the first person of color and the first person of Polynesian
- 5 ancestry to hold the position of United States Senate Sergeant
- 6 at Arms. Mr. Giugni died in 2005. Funded by the United States
- 7 Department of Education through a congressionally-directed
- 8 grant, the moving image archive is dedicated to the care of
- 9 film, videotape, and audiovisual materials, as well as the
- 10 preservation of Hawaii's rich moving image tradition.
- 11 'Ulu'ulu: The Henry Ku'ualoha Giugni Moving Image Archive of
- 12 Hawai'i will be located at the University of Hawaii, West Oahu,
- 13 and will include an online archive of recently preserved and
- 14 digitized materials and an English and Hawaiian language
- 15 website.
- 16 The purpose of this Act is to designate 'Ulu'ulu: The Henry
- 17 Ku'ualoha Giugni Moving Image Archive of Hawai'i as the state



- 1 archive for moving images and establish a special fund for its
- 2 support.
- 3 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 4 amended by adding a new section to part IV, to be appropriately
- 5 designated and to read as follows:
- 6 "\$304A-A 'Ulu'ulu: The Henry Ku'ualoha Giugni Moving Image
- 7 Archive of Hawai'i. 'Ulu'ulu: The Henry Ku'ualoha Giugni Moving
- 8 Image Archive of Hawai'i is designated as the official state
- 9 archive for moving images. The qualifying standards and
- 10 conditions related to the receipt of funds contained in chapter
- 11 42F shall not apply to funds received by 'Ulu'ulu: The Henry
- 12 Ku'ualoha Giugni Moving Image Archive of Hawai'i; provided that
- 13 if the archive contracts with a recipient or provider, the
- 14 qualifying standards, conditions, and other provisions of
- 15 chapter 42F shall apply to the recipient or provider and the
- 16 contract."
- 17 SECTION 3. Chapter 304A, Hawaii Revised Statutes, is
- 18 amended by adding a new section to part V, subpart C, to be
- 19 appropriately designated and to read as follows:
- 20 "\$304A- 'Ulu'ulu: The Henry Ku'ualoha Giugni Moving Image
- 21 Archive of Hawai'i special fund. There is established the

- 1 'Ulu'ulu: The Henry Ku'ualoha Giugni Moving Image Archive of
- 2 Hawai'i special fund into which shall be deposited any
- 3 legislative appropriations, federal or private grants, and any
- 4 other funds collected for the purposes of the 'Ulu'ulu: The
- 5 Henry Ku'ualoha Giugni Moving Image Archive of Hawai'i designated
- 6 under section 304A-A. The fund shall be administered and
- 7 expended by the University of Hawaii. Moneys in the fund shall
- 8 be expended to support the activities of the moving image
- 9 archive."
- 10 SECTION 4. In codifying the new section added by section 2
- 11 of this Act, the revisor of statutes shall substitute
- 12 appropriate section numbers for the letters used in designating
- 13 the new sections in this Act.
- 14 SECTION 5. New statutory material is underscored.
- 15 SECTION 6. This Act shall take effect on July 1, 2012.
