BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Chapter 577, Hawaii Revised Statutes, is
 amended by adding a new section to be appropriately designated
 and to read as follows:

 Child death; reporting. (a) A parent, guardian,
- or other person having the care, custody, or control of a child
- 6 under fourteen years of age shall report the death of the child
- 7 to law enforcement within twenty-four hours after learning of
- 8 the death of the child, if the child died under circumstances
- 9 that would lead a reasonable person to believe that the death
- 10 occurred as the result of a crime.
- (b) Any person who knowingly, intentionally, or wilfully
- 12 violates subsection (a) shall be guilty of a class C felony."
- SECTION 2. Section 577-27, Hawaii Revised Statutes, is

Report Title:

Children; Missing; Child Death; Reporting; Offenses

Description:

Requires a parent, guardian, or other person having the care, custody, or control of a child under age fourteen to report the death of the child to law enforcement within twenty-four hours if the child died under circumstances that would lead a reasonable person to believe that the death occurred as the result of a crime; requires a parent, guardian, or other person to report a missing child under age fourteen to law enforcement within twenty-four hours after learning that the child is missing if the child disappeared under circumstances that would lead a reasonable person to believe that the disappearance occurred as the result of a crime; establishes offenses for failure to report.
