- 4 "S . Community based governance on Hawaiian home
- 5 lands. It is the policy of the State to support participation
- 6 in governance by promoting the empowerment of democratically-
- 7 <u>elected Hawaiian homestead community self-governance</u>
- 8 organizations.
- 9 In furtherance of this policy, the commission may establish
- 10 a working relationship with a democratically-elected Hawaiian
- 11 homestead community self-governance organization to promote
- 12 community welfare. The commission may establish criteria to
- 13 determine the boundaries and location of a Hawaiian homestead
- 14 community and to qualify an organization as a democratically-
- 15 elected Hawaiian homestead community. Criteria for eligibility
- 16 shall include but not be limited to the following:
- 17 (1) The organization and its leadership is a bona fide
- representative body of native Hawaiian residents,



1		homestead lessees, qualified successors residing				
2		within the homestead community, and native Hawaiians				
3		who have designated that homestead community as their				
4		primary choice of residence with the department of				
5		Hawaiian home lands and who are awaiting an award of a				
6		lease under this Act;				
7	(2)	The organization is governed by free and fair				
8		elections; and				
9	(3)	The organization demonstrates sufficient capacity to				
10		implement any task the commission authorizes the				
11		organization to perform or to deliver any service that				
12		the department of Hawaiian homelands would otherwise				
13		perform or deliver.				
14	The	commission may contract with and delegate authority to				
15	a Hawaiia	n homestead community self-governance organization to				
16	perform governmental services for the homestead community					
17	represented by that homestead organization. Any such contract					
18	shall include a requirement that the government service shall be					
19	performed	at a level and quality comparable to the services that				
20	would otherwise be provided by the department of Hawaiian home					
21	lands.					

- 1 The department of Hawaiian home lands may adopt rules in
- 2 accordance with chapter 91, Hawaii Revised Statutes, to
- 3 implement this section."
