## A BILL FOR AN ACT

RELATING TO LONG-TERM CARE.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	DE IT ENACTED DI THE LEGISLATURE OF THE STATE OF HAWAII:		
1	SECTION 1. The legislature finds that Hawaii long-term		
2	care stakeholders believe that the fragmentation of the long-		
3	term care system is a major problem. The stakeholders contend		
4	that there is no real long-term care system, every component is		
5	designed for a different purpose, and the components do not work		
6	together.		
7	The legislature also finds that according to the Hawaii		
8	long-term care commission:		
9	(1) State government should assert stronger leadership		
10	over the entire long-term care population, including		
11	those not eligible for public programs;		
12	(2) The successes or failures of long-term care can		
13	contribute to or detract from the success of the other		
14	programs; and		
15	(3) Hawaii's laws are silent on the subject of leadership		
16	over long-term care.		
17	The purpose of this Act is to establish a long-term care

- 1 transformation coordinator for long-term care within the office
- 2 of the governor, and appropriate funds to support the position
- 3 of the deputy healthcare transformation coordinator.
- 4 SECTION 2. (a) There is established a long-term care task
- 5 force under the direction of the deputy healthcare
- 6 transformation coordinator within the office of the healthcare
- 7 transformation coordinator for administrative purposes. The
- 8 purpose of the long-term care task force shall be to identify
- 9 state programs and services related to long-term care and
- 10 determine the feasibility of consolidating existing state

- 12 under a single executive department or division. The task force
- 13 shall convene within thirty days after the effective date of
- 14 this Act.
- 15 (b) The task force shall be composed of:
- 16 (1) The deputy healthcare transformation coordinator
- 17 established pursuant to this Act, who shall serve as
- 18 chairperson;
- 19 (2) One representative from the med-QUEST division of the
- department of human services to be selected by the
- 21 director of human services;

1	(3)	One member from the Aging and Disability Resource
2		Center program, who shall be requested to serve as a
3		representative;

- 4 (4) One member of the home- and community-based services
  5 community, who shall be requested to serve as a
  6 representative;
- 7 (5) One member of the nursing home community, who shall be requested to serve as a representative;
- 9 (6) One member of the acute care hospitals community, who shall be requested to serve as a representative; and
- 11 (7) Additional task force members selected by the task12 force chairperson.
- 13 (c) In carrying out its duties, the task force may request
  14 staff assistance from the department of health, the department
  15 of human services, and other appropriate state and county
  16 executive agencies.
- (d) The members of the task force shall serve without
  compensation, but shall be reimbursed for expenses, including
  travel expenses, necessary for the performance of their duties.

- 21 (1) Identify state programs and services related to long-
- term care;

12	(5)	Formulate a timetable for the transfer of functions;
13	(6)	Provide a timetable for compliance monitoring;
14	(7)	Ensure that appropriations or funds for identified
15		state programs and services are transferred as
16		necessary to the identified executive department or
17		division;
18	(8)	Ensure that all federal and state funds are fully
19		allocated in the course of the transfer of funds;
20	(9)	Resolve any other issues relating to the transfer of
21		functions and funding to ensure the timely and
22		efficient consolidation of responsibility of state

    shall assist the task force in drafting legislation to implement

    the task force's recommendations; provided that the task force

    shall submit its recommendations and proposed legislation, if

    any, to the bureau no later than November 1, 2013. The task

    force shall be dissolved on June 30, 2014.

         SECTION 3. (a) There is established within the office of

    the governor a deputy healthcare transformation coordinator for

    long-term care to coordinate all state activities on long-term

    care relating to financing, access, service delivery, and

    quality assurance. The deputy healthcare transformation
