
A BILL FOR AN ACT

RELATING TO THE HOMELESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that homelessness
2 continues to be one of the State's most significant and
3 challenging social problems. The legislature further finds that
4 according to a recent report, 14,200 homeless individuals were
5 served through shelter and outreach programs in fiscal year
6 2011. Of these individuals, 9,781 resided in the city and
7 county of Honolulu. The legislature also finds that homeless
8 service providers estimate that 6,000 homeless people in the
9 State need shelter each night.

10 The legislature additionally finds that homelessness is a
11 complex issue that requires continuous resources and coordinated
12 efforts at all levels. The legislature also finds that homeless
13 persons face a myriad of issues, including mental illness,
14 substance abuse, loss of employment and income, and lack of
15 affordable housing. Appropriate funding for programs and
16 services tailored to address these issues is essential.



1 The purpose of this Act is to better assist individuals
2 facing or experiencing homelessness by funding various homeless
3 and housing programs.

4 SECTION 2. There is appropriated out of the general
5 revenues of the State of Hawaii the sum of \$200,000 or so much
6 thereof as may be necessary for fiscal year 2012-2013 for the
7 homeless programs office of the department of human services, to
8 assist homeless and at-risk homeless individuals and families
9 with housing placement, health, education, employment, and other
10 support services.

11 The sum appropriated shall be expended by the department of
12 human services for the purposes of this Act.

13 SECTION 3. There is appropriated out of the general
14 revenues of the State of Hawaii the sum of \$15,000,000 or so
15 much thereof as may be necessary for fiscal year 2012-2013 for
16 the rental housing trust fund.

17 The sum appropriated shall be expended by the Hawaii
18 housing finance and development corporation for the purposes of
19 this Act.

20 SECTION 4. There is appropriated out of the general
21 revenues of the State of Hawaii the sum of \$2,990,300 or so much
22 thereof as may be necessary for fiscal year 2012-2013 for



1 substance abuse treatment and mental health support services for
2 individuals who are homeless or at risk of becoming homeless.

3 The sum appropriated shall be expended by the department of
4 health for the purposes of this Act.

5 SECTION 5. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$3,831,300 or so much
7 thereof as may be necessary for fiscal year 2012-2013 for clean
8 and sober housing support services to be administered by the
9 alcohol and drug abuse division of the department of health.

10 The sum appropriated shall be expended by the department of
11 health for the purposes of this Act.

12 SECTION 6. There is appropriated out of the general
13 revenues of the State of Hawaii the sum of \$2,000,000 or so much
14 thereof as may be necessary for fiscal year 2012-2013 for a
15 homeless prevention program, to be administered by the homeless
16 programs office of the department of human services, for short-
17 term assistance to prevent homelessness and obtain or retain
18 permanent housing.

19 The sum appropriated shall be expended by the department of
20 human services for the purposes of this Act.

21 SECTION 7. There is appropriated out of the general
22 revenues of the State of Hawaii the sum of \$1,500,000 or so much



1 thereof as may be necessary for fiscal year 2012-2013 for a
2 rental assistance program, also known as a shallow subsidy
3 program for sheltered homeless who are ready to rent permanent
4 housing in order to obtain and maintain permanent housing;
5 provided that the maximum subsidy shall be \$300 per month after
6 households pay a minimum of thirty per cent of their adjusted
7 income for rent.

8 The sum appropriated shall be expended by the department of
9 human services for the purposes of this Act.

10 SECTION 8. There is appropriated out of the general
11 revenues of the State of Hawaii the sum of \$200,000 or so much
12 thereof as may be necessary for fiscal year 2012-2013 to provide
13 matching funds for shelter plus care grants.

14 The sum appropriated shall be expended by the department of
15 human services for the purposes of this Act.

16 SECTION 9. This Act shall take effect on July 1, 2050.

Homeless; Housing; Substance Abuse; Mental Health; Appropriation

Description:

Appropriates funds to the homeless programs office of the department of human services and the rental housing trust fund. Appropriates funds to the department of health for substance abuse treatment, mental health support services, and clean and sober housing services and the department of human services for a homeless prevention program, rental assistance program, and matching funds for shelter plus care grants. Effective July 1, 2050. (SD1)
