A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the national and SECTION 1. 2 global economic crisis that began in the second half of 2008 has 3 caused significant economic problems in numerous industries in 4 the State, including the airline, cruise ship, tourist, and 5 construction industries. Mass layoffs have been reported by an 6 increasing number of Hawaii businesses statewide, from the 7 agricultural sector to the medical-services sector. Difficult 8 economic times and declining tax revenues have resulted in 9 budget cuts for all state services. 10 The current and impending situation jeopardizes the safety net of basic human services, health, and education needs for 11 12 Hawaii's residents and families. While all of Hawaii's residents will be affected by the situation, gap group families 13 14 and families closest to the poverty line will suffer the most. 15 Pursuant to Act 304, Session Laws of Hawaii 1999, the 16 legislature established the emergency and budget reserve fund,

which is codified in section 328L-3, Hawaii Revised Statutes, as

a temporary supplemental source of funding for the State of

- 1 Hawaii in times of emergency, economic downturn, or unforeseen
- 2 reduction in revenues. As set forth in section 328L-3, Hawaii
- 3 Revised Statutes, specific purposes for the fund include
- 4 maintaining levels of programs determined to be essential to
- 5 public health, safety, welfare, and education. Section 328L-3,
- 6 Hawaii Revised Statutes, also includes certain prohibitions on
- 7 appropriations from the emergency and budget reserve fund.
- 8 Appropriations for the following purposes are specifically
- 9 prohibited:
- 10 (1) To meet expenses of the legislature;
- 11 (2) To provide for salary adjustments for officials
- 12 appointed pursuant to article V, section 6; or article
- VI, section 3, of the Hawaii State Constitution and
- for others whose salaries are directly related to
- salaries of these officials; and
- 16 (3) To fund cost items in any collective bargaining
- 17 contract.
- 18 The legislature finds that expenditures from the emergency
- 19 and budget reserve fund are needed to meet the conditions of
- 20 emergency, economic downturn, and unforeseen reduction in
- 21 revenues that the State currently faces. Further, the
- 22 legislature finds that the appropriations in this Act are



- 1 consistent with the purposes of the emergency and budget reserve
- 2 fund.
- 3 The purpose of this Act is to appropriate moneys from the
- 4 emergency and budget reserve fund of the State of Hawaii to
- 5 maintain the levels of programs determined to be essential to
- 6 education, public health, and public welfare.
- 7 SECTION 2. There is appropriated out of the emergency and
- 8 budget reserve fund of the State of Hawaii the sum of
- 9 \$ or so much thereof as may be necessary for fiscal
- 10 year 2012-2013 for respite services.
- 11 The sum appropriated shall be expended by the department of
- 12 health for the purposes of this Act.
- 13 SECTION 3. There is appropriated out of the emergency and
- 14 budget reserve fund of the State of Hawaii the sum of
- 15 \$ or so much thereof as may be necessary for fiscal
- 16 year 2012-2013 to supplement the healthy start program.
- 17 The sum appropriated shall be expended by the department of
- 18 health for the purposes of this Act.
- 19 SECTION 4. There is appropriated out of the emergency and
- 20 budget reserve fund of the State of Hawaii the sum of
- 21 \$ or so much thereof as may be necessary for fiscal

- 1 year 2012-2013 to provide funding for grants pursuant to chapter
- 2 42F, Hawaii Revised Statutes, to Waikiki Community Center.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this Act.
- 5 SECTION 5. There is appropriated out of the emergency and
- 6 budget reserve fund of the State of Hawaii the sum of
- 7 \$ or so much thereof as may be necessary for fiscal
- 8 year 2012-2013 for the kupuna care program.
- 9 The sum appropriated shall be expended by the department of
- 10 health for the purposes of this Act.
- 11 SECTION 6. There is appropriated out of the emergency and
- 12 budget reserve fund of the State of Hawaii the sum of
- 13 \$ or so much thereof as may be necessary for fiscal
- 14 year 2012-2013 for the aging and disability resource center.
- The sum appropriated shall be expended by the department of
- 16 health for the purposes of this Act.
- 17 SECTION 7. There is appropriated out of the emergency and
