A BILL FOR AN ACT

RELATING TO AGRICULTURAL POLICY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The convenience of modern society has provided
- 2 people with a variety of inexpensive food choices but has
- 3 eliminated our connection and understanding of where food comes
- 4 from, resulting in less healthful eating and a distancing from
- 5 the natural environment that we depend on.
- 6 A report made to the twenty-sixth legislature in response
- 7 to Senate Concurrent Resolution No. 121, S.D. 1, H.D. 1, through
- 8 the collaboration of private, public, and nonprofit entities,
- 9 pointed to the problems of food insecurity and growing obesity
- 10 rates that the State of Hawaii is facing. One in every three
- 11 children born in the year 2000 is expected to develop diabetes
- 12 and the 2003 food security task force report found that over
- 13 nineteen percent of Hawaii residents live in food insecure
- 14 households. Supporting local agriculture through initiatives
- 15 like a farm-to-school program can serve to combat both of these
- 16 problems.
- 17 Increasing the consumption of locally grown foods will
- 18 ensure that fresh, high quality produce is available for healthy

- 1 meals in schools, hospitals, and correctional facilities
- 2 throughout the State. The increased revenue for local farmers
- 3 will reverse the trend of farmers struggling to break even, and
- 4 will place agriculture at the forefront as a driving economic
- 5 force providing job creation and food security for our State.
- 6 Furthermore, the availability of local produce will ensure our
- 7 children eat the highest quality food that will nourish their
- 8 bodies, enhance their educational experience, and cultivate
- 9 long-term healthy habits.
- 10 The purpose of this Act is to establish a policy to buy
- 11 local produce and support local agriculture and codify that
- 12 policy in chapter 226, Hawaii Revised Statutes, the Hawaii State
- 13 Planning Act.
- 14 SECTION 2. Section 226-7, Hawaii Revised Statutes, is
- 15 amended by amending subsection (b) to read as follows: •
- 16 "(b) To achieve the agriculture objectives, it shall be
- 17 the policy of this State to:
- 18 (1) Establish a clear direction for Hawaii's agriculture
- 19 through stakeholder commitment and advocacy.
- 20 (2) Encourage agriculture by making best use of natural
- resources.

1	(3)	Provide the governor and the legislature with
2		information and options needed for prudent decision
3		making for the development of agriculture.
4	(4)	Establish strong relationships between the
5		agricultural and visitor industries for mutual
6		marketing benefits.
7	(5)	Foster increased public awareness and understanding of
8		the contributions and benefits of agriculture as a
9		major sector of Hawaii's economy.
10	(6)	Seek the enactment and retention of federal and state
11		legislation that benefits Hawaii's agricultural
12		industries.
13	(7)	Strengthen diversified agriculture by developing an
14		effective promotion, marketing, and distribution
15		system between Hawaii's producers and [consumer
16		markets locally, on the continental United States, and
17		internationally.] consumers in the State, nation, and
18		world.
19	(8)	Support research and development activities that
20		strengthen economic productivity in agriculture,
21		stimulate greater efficiency, and enhance the

1		development of new products and agricultural by-
2		products.
3	(9)	Enhance agricultural growth by providing public
4		incentives and encouraging private initiatives.
5	(10)	Assure the availability of agriculturally suitable
6		lands with adequate water to accommodate present and
7		future needs.
8	(11)	Increase the attractiveness and opportunities for an
9		agricultural education and livelihood.
10	(12)	Expand Hawaii's agricultural base by promoting growth
11		and development of flowers, tropical fruits and
12		plants, livestock, feed grains, forestry, food crops,
13		aquaculture, and other potential enterprises.
14	(13)	Promote economically competitive activities that
15		increase Hawaii's agricultural self-sufficiency[.]
16		including the increased purchase of Hawaii-grown foods
17		by residents and increased use by governmental bodies
18		as defined under section 103D-104.
19	(14)	Promote and assist in the establishment of sound
20		financial programs for diversified agriculture.

1	(15)	Institute and support programs and activities to
2		assist the entry of displaced agricultural workers
3		into alternative agricultural or other employment.
4	(16)	Facilitate the transition of agricultural lands in
5		economically nonfeasible agricultural production to
6		economically viable agricultural uses."
7	SECT	ION 3. Section 226-103, Hawaii Revised Statutes, is
8	amended by	y amending subsection (d) to read as follows:
9	"(d)	Priority guidelines to promote the growth and
10	developme	nt of diversified agriculture and aquaculture:
11	(1)	Identify, conserve, and protect agricultural and
12		aquacultural lands of importance and initiate
13		affirmative and comprehensive programs to promote
14		economically productive agricultural and aquacultural
15		uses of such lands.
16	(2)	Assist in providing adequate, reasonably priced water
17		for agricultural activities.
18	(3)	Encourage public and private investment to increase
19		water supply and to improve transmission, storage, and
20		irrigation facilities in support of diversified
21		agriculture and aquaculture.

1	(4)	Assist in the formation and operation of production
2		and marketing associations and cooperatives to reduce
3		production and marketing costs.
4	(5)	Encourage and assist with the development of a
5		waterborne and airborne freight and cargo system
6		capable of meeting the needs of Hawaii's agricultural
7		community.
8	(6)	Seek favorable freight rates for Hawaii's agricultural
9		products from interisland and overseas transportation
10		operators.
11	(7)	Encourage the development and expansion of
12		agricultural and aquacultural activities which offer
13		long-term economic growth potential and employment
14		opportunities.
15	(8)	Continue the development of agricultural parks and
16		other programs to assist small independent farmers in
17		securing agricultural lands and loans.
18	(9)	Require agricultural uses in agricultural subdivisions
19		and closely monitor the uses in these subdivisions.
20	(10)	Support the continuation of land currently in use for
21		diversified agriculture.

1	(11) Encourage residents and visitors to support Hawaii's
2	farmers by purchasing locally-grown products."
3	SECTION 4. Statutory material to be repealed is bracketed
4	and stricken. New statutory material is underscored.
5	SECTION 5. This Act shall take effect upon its approval.

POLICY.

PURPOSE:

Codify the objective to purchase locally produced agricultural commodities in the Hawaii State Planning Act to show the intent of the State to move towards greater food

security.

MEANS:

Amend sections 226-7(b) and 226-103(d),

Hawaii Revised Statutes.

JUSTIFICATION:

The amendments to the Hawaii State Planning Act reflect the desire of the Department of Agriculture to emphasize the importance of supporting local agriculture in the movement towards greater food safety, food security, and self-sustainability. This amendment would serve as a quideline that can be used by the State and counties in the creation of long-term plans for the future of Hawaii and the increased role that local agriculture would play in those plans.

Impact on the public: Would provide a vision for an increase in locally produced agricultural commodities.

Impact on the department and other agencies: Would emphasize the consumption of locally produced agricultural commodities by

governmental bodies.
