A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The convenience of modern society has provided people with a variety of inexpensive food choices but it has 2 3 eliminated our connection to and understanding of where food 4 comes from, resulting in less healthful eating and a distancing 5 from natural food sources. 6 A report made to the twenty-sixth legislature in response 7 to Senate Concurrent Resolution No. 121, S.D. 1, H.D. 1, through 8 the collaboration of private, public, and nonprofit entities, 9 pointed to the problems of food insecurity and growing obesity 10 rates that the State of Hawaii is facing. One in every three 11 children born in the year 2000 is expected to develop diabetes **12** and the 2003 food security task force report found that over 13 nineteen percent of Hawaii residents live in food insecure 14 households. Food insecurity is defined in that report as 15 "whenever the availability of nutritionally adequate and safe 16 foods or the ability to acquire acceptable foods in socially 17 acceptable ways is limited or uncertain". Supporting local

- 1 agriculture through initiatives like a farm-to-school program
- 2 can serve to combat both of these problems.
- 3 Increasing the consumption of locally grown foods will
- 4 ensure that fresh, high quality produce is available for healthy
- 5 meals in schools, hospitals, and correctional facilities
- 6 throughout the State. The increased revenue for local farmers
- 7 will reverse the trend of farmers struggling to break even, and
- 8 will place agriculture at the forefront as a driving economic
- 9 force providing job creation and food security for our State.
- 10 Furthermore, the availability of local produce will ensure our
- 11 children eat the highest quality food that will nourish their
- 12 bodies, enhance their educational experience, and cultivate
- 13 long-term healthy habits.
- 14 The purpose of this Act is to amend section 103D-102,
- 15 Hawaii Revised Statutes, to ease the process required for
- 16 governmental bodies to acquire local agricultural commodities.
- 17 SECTION 2. Section 103D-102, Hawaii Revised Statutes, is
- 18 amended by amending subsection (b) to read as follows:
- "(b) Notwithstanding subsection (a), this chapter shall
- 20 not apply to contracts by governmental bodies:

15			to pay by law, including paying fees, permanent
16			settlements, subsidies, or other claims, making
17			refunds, and returning funds held by the State as
18			trustee, custodian, or bailee;
19		(D)	For entitlement programs, including public
20			assistance, unemployment, and workers'
21			compensation programs, established by state or
22			federal law:

1		(E)	For dues and fees of organizations of which the
2			State or its officers and employees are members,
3			including the National Association of Governors,
4			the National Association of State and County
5			Governments, and the Multi-State Tax Commission;
6		(F)	For deposit, investment, or safekeeping,
7			including expenses related to their deposit,
8			investment, or safekeeping;
9		(G)	To governmental bodies of the State;
10		(H)	As loans, under loan programs administered by a
11			governmental body; and
12		(I)	For contracts awarded in accordance with chapter
13			103F;

17		by regulatory processes or agencies;
18	(G)	Performances, including entertainment, speeches,
19		and cultural and artistic presentations;
20	(H)	Goods and services for commercial resale by the
21		State;

1		(+)	services or princers, racing agencies, support
2			facilities, fiscal and paying agents, and
3			registrars for the issuance and sale of the
4	•		State's or counties' bonds;
5		(J)	Services of attorneys employed or retained to
6			advise, represent, or provide any other legal
7			service to the State or any of its agencies, on
8			matters arising under laws of another state or
9			foreign country, or in an action brought in
10			another state, federal, or foreign jurisdiction,
11			when substantially all legal services are
12			expected to be performed outside this State;
13		(K)	Financing agreements under chapter 37D; and
14		(L)	Any other goods or services which the policy
15			board determines by rule or the chief procurement
16			officer determines in writing is available from
17			multiple sources but for which procurement by
18			competitive means is either not practicable or
19			not advantageous to the State;
20	(5)	Whic	h are specific procurements expressly exempt from
21		any	or all of the requirements of this chapter by:

1		(A)	References in state or federal law to provisions
2			of this chapter or a section of this chapter, or
3			references to a particular requirement of this
4			chapter; and
5		(B)	Trade agreements, including the Uruguay Round
6			General Agreement on Tariffs and Trade (GATT)
7			which require certain non-construction and non-
8			software development procurements by the
9			comptroller to be conducted in accordance with
10			its terms; and
11	(6)	With	a bidder or offeror who is a United States
12		Gene	ral Services Administration-approved sole source
13		vend	or, who shall be exempt from complying with
14		sect	ion 103D-302, 103D-303, or 103D-304, as

16		fede	ral matching funds, if the bidder or offeror was

JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO PROCUREMENT.

PURPOSE:

To exempt the purchase of fresh meats and produce and animals and plants by any governmental body from the Hawaii Public

Procurement Code.

MEANS:

Amend section 103D-102(b) and repeal section 103D-104.5, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

Act 175, Session Laws of Hawaii 2009, added section 103D-104.5, HRS, which explicitly subjects the purchase of fresh meat and produce and animals and plants to the Procurement Code. Purchase of fresh meat and produce and animals and plants by governmental agencies has been problematic with agencies having to issue solicitations for these volatile items due to market pricing and availability. This requirement to competitively procure these items has not proven an efficient process for agencies.

Exempting these purchases from the Procurement Code will allow agencies to more efficiently purchase these items that are highly perishable, vary in availability, quality, and quantity, and to acquire these items from best available sources on an as needed basis.

Impact on the public: Expediting the
processes to obtain needed goods.

Impact on the department and other agencies: This bill will simplify and expedite the processes to obtain the required goods in a timely manner.
