BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 84-11, Hawaii Revised Statutes, is

Ethics; Charitable Events; Legislators; State Employees

Description:

Exempts from restrictions on gifts under the ethics code invitations or complimentary tickets to a widely attended charitable event from a charitable entity, whether or not the charitable entity is the host of the charitable event. Requires disclosure. Effective July 1, 2012.

A BILL FOR AN ACT RELATING TO LIMITED

EXEMPTION UNDER STATE ETHICS CODE REGARDING

CHARITABLE EVENTS.

PURPOSE:

Provides a limited exemption under the State Ethics Code to permit legislators and state

employees to accept invitations or complimentary tickets from charitable entities to widely attended charitable

events, except for golf tournaments.

MEANS:

Amend sections 84-11 and 84-13, Hawaii

Revised Statutes.

JUSTIFICATION:

Charitable entities often fulfill important public functions, such as direct services to low-income and disadvantaged persons, and other public benefits. Attendance by lawmakers and government officials at events sponsored by charitable entities provides them with educational opportunities to help keep them current with community issues. Accordingly, invitations or complimentary tickets to such events, excluding golf tournaments, for legislators and state employees should be exempt from the prohibitions of section 84-11, Hawaii Revised Statutes. Nevertheless, the receipt and actual value of the invitations or complimentary tickets, as determined by the charitable entity, are still subject to reporting requirements. Actual value of the invitation or complimentary ticket may not be the same as the nominal or face value. For example, if the face value is "free", but the actual value of the invitation or ticket as determined by the charitable entity is \$100, the actual value of \$100 shall be reported. Conversely, if the face value is \$200, but the actual value of the invitation or ticket as determined by the

charitable entity is \$75, the actual value of \$75 shall be reported.

Impact on the public: The impact on the public should be positive because the proposed amendment will permit legislators and state employees to attend charitable events and obtain current information on community issues.
