A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION FOR REIMBURSEMENT OF COSTS
RELATED TO THE ASIA-PACIFIC ECONOMIC COOPERATION MEETINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the state constitution.
- 4 SECTION 2. A critical need exists to reimburse seven state
- 5 departments for the costs of providing emergency management,
- 6 public safety, and security in preparation for and during the
- 7 Asia-Pacific Economic Cooperation meetings held in Hawaii in
- 8 November 2011. Federal reimbursement of these costs is being
- 9 sought; however, reimbursement is not guaranteed and, if
- 10 granted, is not likely to be received within the current fiscal
- 11 year.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$2,709,966 or so much
- 14 thereof as may be necessary for fiscal year 2011-2012 to
- 15 reimburse the moneys expended by the seven state departments for
- 16 costs related to the Asia-Pacific Economic Cooperation meetings.

- 1 The sum appropriated shall be expended by the department of
- 2 defense for the purposes of this Act.
- 3 SECTION 4. Subject to the approval of the governor, the
- 4 department of defense may transfer funds to the respective seven
- 5 state departments to reimburse the departments for costs
- 6 associated with providing emergency management, public safety,
- 7 and security for the Asia-Pacific Economic Cooperation meetings
- 8 held in November 2011.
- 9 SECTION 5. Any reimbursement received from the federal
- 10 government for costs incurred by state agencies to provide
- 11 emergency management, public safety, and security for the Asia-
- 12 Pacific Economic Cooperation meetings held in November 2011, and
- 13 for which the moneys appropriated by this Act have been
- 14 appropriated to replace, shall be deposited into the general
- 15 fund.
- 16 SECTION 6. This Act shall take effect upon its approval.
