A BILL FOR AN ACT

RELATING TO THE HAWAIIAN HOMES COMMISSION ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. As the department of Hawaiian home lands
- 2 develops various new homestead products, such as multifamily
- 3 units, rentals, and kupuna housing, to meet the needs of its
- 4 longest waiting applicants, the ability to suspend certain
- 5 provisions of title 10 of the Hawaii Administrative Rules can
- 6 eliminate barriers that have prevented Hawaiian home lands
- 7 applicants from accepting a homestead lease.
- 8 This measure targets these applicants who have been on the
- 9 waiting list for at least twenty years. Any applicant on the
- 10 waiting list for this period of time has received multiple
- 11 offers for lease awards, but has not been able to accept the
- 12 lease.
- 13 SECTION 2. Section 207, Hawaiian Homes Commission Act,
- 14 1920, as amended, is amended by amending subsection (b) to read
- 15 as follows:
- 16 "(b) The title to lands so leased shall remain in the
- 17 State. Applications for tracts shall be made to and granted by
- 18 the department, under such regulations, not in conflict with any SB2793 HD1 HMS 2012-2861-1

- 1 provisions of this title, as the department may prescribe. The
- 2 chairperson of the Hawaiian homes commission, with unanimous
- 3 consent from the commission, may award a lease to any native
- 4 Hawaiian with an original application date of not less than
- 5 twenty years from the date of the approval. The department
- 6 shall, whenever tracts are available, enter into such a lease
- 7 with any applicant who, in the opinion of the department, is
- 8 qualified to perform the conditions of such lease."
- 9 SECTION 3. New statutory material is underscored.
- 10 SECTION 4. This Act shall take effect on July 1, 2050;
- 11 provided that this Act shall be repealed on June 30, 2017, and
- 12 section 207, Hawaiian Homes Commission Act, 1920, as amended,
- 13 shall be reenacted in the form in which it read on the day
- 14 before the effective date of this Act.

Allows the chair of the Hawaiian Homes Commission, with unanimous consent of the Commission, to suspend administrative rules for the purpose of awarding a lease to a native Hawaiian who has been on the waitlist for at least twenty years. Repeals June 30, 2017. Effective July 1, 2050. (SB2793 HD1)
