
# A BILL FOR AN ACT

RELATING TO THE HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness is a
- 2 societal problem that has plagued Hawaii and the nation for many
- 3 years. Although great strides have been made to address the
- 4 issue of homelessness, Hawaii has experienced an increase in the
- 5 number of homeless persons. Homelessness remains a complex
- 6 issue involving coordination, planning, implementation, and
- 7 funding among state and county agencies, nonprofit entities, and
- 8 the federal government.
- 9 On June 22, 2010, the cabinet secretaries from the federal
- 10 Departments of Housing and Urban Development, Labor, Health and
- 11 Human Services, and Veterans Affairs joined the United States
- 12 Interagency Council on Homelessness to unveil and submit to the
- 13 President and Congress the nation's first comprehensive
- 14 strategic plan to prevent and end homelessness. The United
- 15 States Interagency Council on Homelessness is composed of
- 16 nineteen federal agencies to coordinate the nation's housing,
- 17 health, employment security, education, and human services
- 18 functions to create a national partnership among every level of





- 1 government and the private sector to maximize the effectiveness
- 2 of the federal government's response in addressing homelessness.
- 3 Described by the federal government as the most ambitious
- 4 program in history to prevent and end homelessness, the
- 5 strategic plan will strengthen existing programs and forge new
- 6 partnerships. Working together with Congress, state and local
- 7 officials, faith-based and community organizations, and business
- 8 and philanthropic leaders across the country, the plan will
- 9 harness public and private resources to build on proven local-
- 10 level innovations.
- 11 The legislature finds that Hawaii must have a mechanism
- 12 similar to the United States Interagency Council on Homelessness
- 13 to formulate and coordinate a unified plan to address
- 14 homelessness in all counties and facilitate the acquisition of
- 15 federal funding for homeless programs. The United States
- 16 Interagency Council on Homelessness recommends that the states
- 17 establish such a state agency by legislative action or executive
- 18 order, or both.
- 19 The purpose of this Act is to establish the Hawaii
- 20 interagency council on homelessness.
- 21 SECTION 2. (a) There is established the Hawaii
- 22 interagency council on homelessness, which shall be an advisory

- 2 council shall be attached to the department of human services
- 3 for administrative purposes. The director of human services
- 4 shall serve as the ad hoc coordinator of the council. The
- 5 members of the council shall serve without compensation but
- 6 shall be reimbursed for expenses, including travel expenses,
- 7 necessary for the performance of their duties.
- **8** (b) The council shall:
- 9 (1) Be responsible for organizing its member entities to
- formulate and coordinate a unified plan to address
- 11 homelessness in all counties and facilitate the
- 12 acquisition of federal funding for homeless programs;
- 13 (2) Serve as the statewide homelessness planning and
- 14 policy development entity with broad representation
- from state and county government and the community;
- 16 (3) Formulate and advise on the implementation of a
- 17 unified, statewide plan to address homelessness in all
- 18 counties;
- 19 (4) Consider collaborative homelessness initiatives of
- 20 other states that have demonstrated positive
- 21 measurable outcomes as possible models for state and
- 22 local programs;

21		human services, to be designated by the director of
22		human services;

1	SECTION 4. The council shall meet quarterly, or more
2	frequently as it deems necessary. A majority of the council
3	members shall constitute a quorum to do business and to validate
4	any decision or act of the council.
5	If a council member is unable to attend a meeting, the
6	member may appoint a designee to attend and to act on the
7	member's behalf during the meeting.
8	SECTION 5. The council shall have the duties as provided
9	in section 2(b) of this Act; provided that:
10	(1) The council may prioritize the duties, adapt or modify
11	any duty to the circumstances, and refrain from
12	exercising any duty if changing circumstances make the
13	duty no longer necessary or if a particular duty
14	conflicts with another law or duty of another agency;
15	and
16	(2) The council shall endeavor to coordinate the duties,
17	responsibilities, and functions of all members of the
18	council.
19	SECTION 6. The unified, statewide plan under section
20	2(b)(3) of this Act shall be developed to:
21	(1) Assist individuals who are homeless or facing

1	(2)	Prioritize the needs of the most vulnerable
2		individuals and families;
3	(3)	Encourage and promote partnerships between public and
4		private entities to identify, renovate, and secure
5		dignified transitional as well as permanent housing
6		options;
7	(4)	Promote development and utilization of support
8		services including job training, mental health, and
9		substance abuse treatment that will enhance the
10		transition out of homelessness;
11	(5)	Increase access to public areas for all members of the

Homelessness; Interagency Council; Department of Human Services

Requires the Department of Human Services to conduct a study on establishing safe havens in the State and to submit a report to the Legislature prior to the 2013 Regular Session. Effective July 1, 2030. (SB2804 HD2)
