A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Hawaii State Constitution.
- 4 SECTION 2. A critical fiscal emergency exists. On May 19,
- 5 2010, United States District Judge J. Michael Seabright ordered
- 6 the State of Hawaii to pay to the law firms of Alston Hunt Floyd
- 7 and Ing and Lawyers for Equal Justice the amount of \$70,124.05
- 8 as attorneys' fees awarded for being the prevailing party in the
- 9 lawsuit Sound v. Koller, Civil No. 09-00409 JMS KSC.
- 10 Although a request was made for payment of this amount from
- 11 general funds during the regular session of 2011, the
- 12 legislature did not appropriate the funds to satisfy this
- 13 indebtedness. As a result, the two law firms sought to garnish
- 14 this amount from a State of Hawaii bank account. To avoid
- 15 garnishment, the department of human services, on advice of its
- 16 counsel, the department of the attorney general, agreed to pay
- 17 to the law firms of Alston Hunt Floyd and Ing and Lawyers for

- 1 Equal Justice \$39,243.15, consisting of general funds from the
- 2 Medicaid program budget for HMS 902, General Support for Health
- 3 Care Payments, in partial payment for the amount owing. Again
- 4 on the advice of its counsel, the department of the attorney
- 5 general, the department of human services also agreed to ask the
- 6 2012 legislature for an expedited appropriation of \$30,880.90 as
- 7 the remaining amount due to the two law firms. In exchange for
- 8 the partial payment and the agreement to request this expedited
- 9 appropriation, the law firms halted their garnishment action
- 10 against the State of Hawaii.
- 11 The purpose of this Act is to appropriate \$70,124.05 in
- 12 general funds for an emergency appropriation for fiscal year
- 13 2011-2012 to satisfy the State's remaining indebtedness of
- 14 \$30,880.90 to the law firms of Alston Hunt Floyd and Ing and
- 15 Lawyers for Equal Justice, and to reimburse the \$39,243.15
- 16 previously expended from the department of human services' HMS
- 17 902, General Support for Health Care Payments budget for payment
- 18 to those law firms, and to ensure that there will be no funding
- 19 shortfall in the Medicaid program as a result of the earlier
- 20 partial payment that would disrupt timely payments to contracted
- 21 health plans in providing medically necessary services to
- 22 program recipients.

1	SECTION 3. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$70,124.05, or so
3	much thereof as may be necessary, for fiscal year 2011-2012 to
4	be used for General Support for Health Care Payments (HMS 902).
5	SECTION 4. The sum appropriated shall be expended by the
6	department of human services for the purposes of this Act.
7	SECTION 5. This Act shall take effect upon its approval.

TITLE:

A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HUMAN

PURPOSE:

Provide for the authorization and payment of claims against the State for payment of attorneys' fees, in the amount of \$70,124.05, owed to the law firms of Alston Hunt Floyd and Ing and Lawyers for Equal Justice for a lawsuit the State lost in 2009, Sound v Koller, Civil No. 09-00409 JMS

KSC.

MEANS:

An emergency appropriation of state general funds for the payment of a claim for attorneys' fees.

JUSTIFICATION:

The bill to appropriate funds for claims and settlements did not pass during the regular session of 2011. Subsequently, the law firm of Alston Hunt Floyd and Ing asked the Federal Court to garnish the State's bank account. To prevent a garnishment action against the State, the Department of Human Services accepted the recommendation of its counsel, the Department of the Attorney General, and agreed to pay \$39,243.15 from the Department of Human Services' general funds for HMS 902, General Support for Health Care Payments, in October 2010. further avoid garnishment against the State, the Department of Human Services also agreed to request an expedited appropriation in the amount of \$30,880.90 from the 2012 Legislature to pay the balance in full owed to Alston Hunt Floyd and Ing and the Lawyers for Equal Justice.

This bill will provide reimbursement for the amount the Department of Human Services has paid to date and will provide funds for the payment of the balance owed.

Impact on the public: There would be no direct impact on the public other than the persons whose claims are being paid.

Impact on the department and other agencies:
Failure to enact this bill may cause the
Federal Court to garnish funds, which the
Department of Human Services would need to
support the timely payment of Medicaid
claims.
