1	SECTION 1. With technological advancement, many consumer
2	electric products become obsolete within a very short period of
3	time, creating large amounts of waste. Limited landfill space
4	is a concern, and disposal of waste electric products into our
5	landfills has the potential to cause human and environmental
6	impacts. Proper waste handling and recycling of valuable
7	materials are important aspects of protecting Hawaii's health
8	and building a green economy.
9	SECTION 2. (a) There is established within the department
10	of health the Hawaii electric device recycling task force to
11	make recommendations for a workable recycling program for
12	electric devices in Hawaii, keeping in mind the conditions and
13	needs of the various islands.
14	(b) The members of the task force shall consist of the

- 4 reducing the size of the task force; provided that the task
- 5 force maintains, to the extent reasonably possible,

- 7 (d) The members of the task force shall serve without
- 8 compensation but shall be reimbursed for expenses, including
- 9 travel expenses, necessary for the performance of their duties.
- 10 (e) The department of health shall submit a report of the
- 11 task force's findings and recommendations, including any
- 12 proposed legislation, to the legislature no later than twenty
- 13 days prior to the convening of the 2013 regular session.
- 14 (f) The task force shall be dissolved on June 30, 2013.
- 15 SECTION 3. This Act shall take effect upon its approval.
