PURPOSE:

Amends the definition of "sailing school vessel" to mean, among other things, a vessel that is in compliance with the Federal Code of Regulations, Title 46, Part

169.

MEANS:

Amend section 200-1, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

Federal Code of Regulations, Title 46, Part 169, governs sailing school vessels. Although the State recognizes the federal code, the definition of "sailing school vessel" within section 200-1, HRS, does not make any reference to the specific federal code itself.

For the sake of formal recognition in state law, this bill amends the definition of "sailing school vessel" to mean, among other things, a vessel that is in compliance with the Federal Code of Regulations, Title 46, Part 169.

Impact on the public: This bill would ensure legitimacy of sailing school vessels operating in Hawaii, by way of having to meet the federal requirements.

Impact on the department and other agencies: This bill would ensure consistency between state and federal law in regulating sailing school vessels.
