## A BILL FOR AN ACT

RELATING TO GROUNDED VESSELS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 200-47.5, Hawaii Revised Statutes, is
2	amended by	y amending subsection (b) to read as follows:
3	"(b)	Solely for the purposes of removal and with no
4	liability	to the department, the department may assume control
5	of any vessel that:	
6	(1)	Is grounded on a coral reef or in imminent danger of
7		breaking up; and
8	(2)	Cannot be immediately removed by the owner within
9		[seventy two] twenty-four hours of actual notification
10		to the vessel owner or the owner's representative by
11		the department and in a manner that is reasonably
12		safe, as determined by the department[-], or for which
13		no effective salvage operation has been initiated
14		within twenty-four hours of grounding.
15	The c	owner of the vessel may continue as the primary agent
16	in salvag	ing the vessel after twenty-four hours upon providing
17	proof of	a marine insurance policy listing the State as an
18	additiona	l insured in the amount of at least \$1,000,000 and



- 1 proof that the owner is actively and effectively initiating a
- 2 salvage effort with reasonable evidence, as determined by the
- 3 department, that the vessel may be saved within seventy-two
- 4 hours of grounding; provided that the department may allow an
- 5 extension beyond the seventy-two hour limit if it determines
- 6 that no additional environmental damage exists. Once the
- 7 department assumes control over the vessel, the vessel shall be
- 8 removed by conventional salvage methods to minimize damage to
- 9 the natural resources and not become a hazard to navigation.
- 10 All costs and expenses of removing the vessel and damage to
- 11 state or private property shall be the sole responsibility of
- 12 the vessel's owner or operator. This section shall apply
- 13 whether the vessel is attended or deemed derelict under section
- **14** 200-48."
- 15 SECTION 2. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 3. This Act shall take effect upon its approval.

## Report Title:

Grounded Vessels

## Description:

Authorizes the Department of Land and Natural Resources to assume control of and remove a vessel grounded on a coral reef or in imminent danger of breaking apart if the vessel cannot be removed by the owner within twenty-four hours of notification to the vessel's owner of the grounding. Provides requirements to allow the owner of the vessel to continue an effort to salvage a grounded vessel beyond twenty-four hours under certain conditions and allows the department to grant more time to the owner to remove the vessel if no additional environmental damage exists. (SB2850 HD1)
