RELATING TO STATE LIBRARIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 312-3.8, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§312-3.8 [Hawaii state library foundation and friends of
4	the library of Hawaii concessions; use of public library
5	facilities.] Use of public library facilities; funds. (a)
6	Notwithstanding any law to the contrary, the Hawaii state public
7	library system, through the state librarian, shall [be
8	authorized to] issue licenses, revocable permits, concessions,
9	or rights of entry for the use of public library system
10	facilities and grounds and for such periods of use as deemed
11	appropriate by the state librarian to [the Hawaii state library
12	foundation and the friends of the library of Hawaii] the Friends
13	of the Library of Hawaii and any tax-exempt non-profit
14	corporation recognized by the Internal Revenue Service under
15	Section 501(c)(3) of the Internal Revenue Code of 1986 whose
16	primary declared purpose is the support of any library within
17	the Hawaii State Public Library System. [for the use of public
18	library system facilities and grounds and for such periods of

- 2 dispositions, including those in excess of fourteen days, need
- 3 not be approved by the board of land and natural resources;
- 4 provided that approval by the board of land and natural
- 5 resources shall be required when such dispositions are for
- 6 periods in excess of one year.
- 7 (b) Notwithstanding any law to the contrary, all net
- 8 income or proceeds received by the Hawaii state library
- 9 foundation and the [friends of the library of Hawaii] Friends of
- 10 the Library of Hawaii from the operation of any concession,
- 11 vending machine, or other for-profit business enterprise within,
- 12 or on the grounds of, any state library facility shall be
- 13 deposited into the Hawaii state library foundation trust fund or
- 14 the [friends of the library of Hawaii] Friends of the Library of
- 15 Hawaii trust fund, as appropriate. All funds deposited into the
- 16 trust funds, including income and capital gains earned
- 17 therefrom, shall be used exclusively for state library programs.
- 18 (c) Notwithstanding any law to the contrary, all net
- 19 income or proceeds received by any tax-exempt non-profit
- 20 corporation, as provided in subsection (a), from the operation
- 21 of any concession, vending machine, or other for-profit business
- 22 enterprise within, or on the grounds of, a state library

- 2 profit corporation. All funds deposited into the trust fund of
- 3 the non-profit corporation, including income and capital gains
- earned therefrom, shall be used exclusively for the library 4
