### A BILL FOR AN ACT

RELATING TO AGRICULTURAL EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature established the Hawaii State
- 2 Planning Act, codified in chapter 226, Hawaii Revised Statutes,
- 3 to, among other things, "identify the goals, objectives,
- 4 policies, and priorities for the State" and "provide a basis for
- 5 determining priorities and allocating limited resources, such as
- 6 public funds, services, human resources, land, energy, water,
- 7 and other resources."
- 8 The legislature finds that the Hawaii State Planning Act
- 9 asserts that it shall be the policy of the State to "[p]romote
- 10 economically competitive activities that increase Hawaii's
- 11 agricultural self-sufficiency" and "[i]ncrease the
- 12 attractiveness and opportunities for an agricultural education
- 13 and livelihood." The legislature further finds that the Act
- 14 ensures and supports quality education that is accessible, and
- 15 ensures environmentally healthful and sanitary conditions for
- 16 all Hawaii residents.
- 17 The legislature further finds that supporting Hawaii's
- 18 agriculture education and school farms is in line with these SB HMS 2012-1092-1



- 1 policy guidelines. In order for Hawaii to continue toward
- 2 agricultural sustainability, it is necessary to educate future
- 3 farmers and ensure the place of local agricultural products in
- 4 Hawaii's markets.
- An important aspect of any agricultural education is that 5
- 6 of food safety. The United States Department of Agriculture
- 7 regularly updates food safety standards and it is imperative to
- 8 include these standards, along with other requirements imposed
- 9 upon farms in the State, in the agricultural curriculum.
- 10 In addition, there is a place for school farms in the
- 11 growing farm to school movement. Students of agriculture can
- 12 build their skills and knowledge while at the same time
- 13 providing fresh, local produce to Hawaii's school cafeterias.
- This can only be the case, however, if the public can be certain 14
- 15 that food grown on a school farm is safe for consumption.
- The purposes of this Act, therefore, are to support 16
- **17** agricultural education and school farms by requiring the
- 18 University of Hawaii to:
- Establish a center for agricultural leadership that 19
- will be primarily responsible for developing the next 20
- 21 generation of agricultural leaders and will conduct
- 22 activities, including pilot projects and demonstration

1	SECTION 3. (a) The University of Hawaii shall establish		
2	two-year pilot project within the center for agricultural		
3	leadershi	p to determine the steps necessary for farms operated	
4	through school programs to achieve food safety certification by		
5	the department of agriculture. The pilot project shall be		
6	conducted at one high school in each county. In order to be		
7	chosen for this pilot project, a high school must currently		
8	maintain	a school farm that has a high likelihood of meeting	
9	current f	ood safety certification requirements.	
10	(b)	The pilot project established under subsection (a)	
11	shall, at minimum:		
12	(1)	Assess the current operations of the school farm;	
13	(2)	Determine the requirements of department of	
14		agriculture food safety certification;	
15	(3)	Interface with the department of agriculture to	
16		identify any potential barriers to school farm food	
17	·	safety certification and generate remedies to such	
18		barriers; and	
19	(4)	Incorporate the process of food safety certification	
20		into any agriculture-related curriculum associated	
21	· .	with the school farm.	

- 1 (c) The University of Hawaii shall submit a progress
- 2 report on the implementation of the school farm pilot project,
- 3 including any difficulties encountered, to the legislature no
- 4 later than twenty days prior to the convening of the regular
- 5 session of 2013, and a final report, including any
- 6 recommendations for legislation, no later than twenty days prior
- 7 to the convening of the regular session of 2014.
- 8 SECTION 4. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so much
- 10 thereof as may be necessary for fiscal year 2012-2013 to
- 11 implement the purposes of this Act.
- 12 The sum appropriated shall be expended by the University of
- 13 Hawaii for the purposes of this Act.
- 14 SECTION 5. This Act shall take effect upon its approval.
