BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that discarded motor 2 vehicle tires continue to blight Hawaii's neighborhoods,
- 4 the motor vehicle tire surcharge, the department of health lost

- resources, or the chairperson's designee;
