A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the department of
2	transportation is charged with the implementation of the bridge
3	rehabilitation and replacement program for bridges with a
4	sufficiency rating of less than eighty to be designed and
5	constructed. There are currently seven hundred fifty-six state-
6	owned bridges, of which two hundred fifty-six are functionally
7	obsolete and thirty-nine of which are structurally deficient.
8	Functionally obsolete bridges are defined as bridges with

- geometric deficiencies such as a bridge being too narrow. 9
- Structurally deficient bridges are defined as bridges with a 10
- 11 poor assessment of the structural condition of the bridge,
- 12 including the waterway opening adequacy.
- 13 There are currently thirty bridges under the jurisdiction
- of the department of transportation that are either functionally 14
- 15 obsolete or structurally deficient and that are in the design
- phase that are planned for rehabilitation and replacement, in 16
- 17 addition to the Hana highway bridge preservation plan, which
- 18 needs to move forward for construction.

1 The purpose of this Act is to expedite construction projects for the bridge rehabilitation and replacement program 2 3 by providing temporary exemptions from certain state and county 4 requirements. 5 SECTION 2. Beginning July 1, 2012, and ending June 30, 6 2017, the department of transportation and any of its 7 contractors shall be exempt from state requirements under the 8 following, but only to the extent necessary to expedite the 9 projects enumerated under section 3 of this Act: 10 Chapter 6E, Hawaii Revised Statutes, historic 11 preservation; 12 Part II of chapter 171, Hawaii Revised Statutes, (2) 13 public lands; 14 (3) Chapter 174C, Hawaii Revised Statutes, state water 15 code; Chapter 180, Hawaii Revised Statutes, soil and water 16 (4)17 conservation districts; 18 (5) Chapter 180C, Hawaii Revised Statutes, soil erosion 19 and sediment control; 20 (6) Chapter 183, Hawaii Revised Statutes, forest reserves, 21 water development, and zoning;

- 3 SECTION 4. If the construction of a project granted an
- 4 exemption under this Act is not completed by June 30, 2017, the
- 5 governor may authorize in writing before that date the
- 6 continuation of construction of the project until completion.
- 7 If so authorized, the project shall continue to be exempt as
- 8 provided under this Act.
- 9 SECTION 5. If any part of this Act is found to be in
- 10 conflict with federal requirements that are a prescribed
- 11 condition for the allocation of federal funds to the State, the
- 12 conflicting part of this Act is inoperative solely to the extent
- 13 of the conflict and with respect to the agencies directly
- 14 affected, and this finding shall not affect the operation of the
- 15 remainder of this Act in its application to the agencies
- 16 concerned. The rules under this Act shall meet federal
- 17 requirements that are a necessary condition to the receipt of
- 18 federal funds by the State.
- 19 SECTION 6. This Act shall take effect upon its approval.
