RELATING TO OFFENSES AGAINST PUBLIC ADMINISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 710, Hawaii Revised Statutes, is			
2	amended by adding a new section to part VI to be appropriately			
3	designated and to read as follows:			
4	"§710- Disrespect of a house of the legislature. (1)			
5	Pursuant to article III, section 18, of the Hawaii state			
6	constitution, a person who is not a member of either house of			
7	the legislature commits the offense of disrespect of a house of			
8	the legislature if, while the person is present at a legislative			
9	session of either house or at a hearing of any committee of			
10	either house, the person exhibits disorderly or contemptuously			
11	behavior.			
12	(2) For purposes of subsection (a), the acts that			
13	constitute disorderly or contemptuous behavior shall include bu			
14	not be limited to:			
15	(a) Making loud, boisterous, or incessant shouts;			
16	(b) Refusing to be or to remain seated on orders from the			
17	sheriff or sergeant-at-arms, in response to behavior			
18	under paragraph (a);
