A BILL FOR AN ACT

RELATING TO CONSERVATION AND RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Chapter 183, Hawaii Revised Statutes, is

 amended by adding a new part to be appropriately designated and

 to read as follows:

 "PART . FOREST RESOURCES IN NEED OF CONSERVATION
- 5 §183-A Definitions. As used in this part:
- 6 "Harvest permit" means a permit issued by the department of
- 7 land and natural resources to destroy, harvest, or export for
- 8 commercial purposes any material of a forest resource, living or
- ${f 9}$ dead, that is deemed in need of conservation.
- 10 "Hawaiian sandalwood" means the Santalum species endemic to
- 11 the islands of Hawaii including but not limited to Santalum
- 12 ellipticum, S. freycinetianum, S. haleakalae var. haleakalae and
- 13 haleakalae var. lanaiense, and S. paniculatum var. paniculatum
- 14 and S. paniculatum var. pilgeri.
- "Native forest resources deemed in need of conservation"
- 16 means those forest species identified by the board as currently
- 17 in decline and in need of conservation.

4	(1)	Support reforestation efforts throughout the State for
5		all native forest resources deemed in need of

9	(3)	Identify and protect native forest resources deemed in
10		need of conservation for sustainable management and
11		conservation of those species and ecosystems;
12	(4)	Establish rules for designating forest resources in
13		need of conservation and establish rules regarding the
14		issuance of permits for commercial harvest of forest
15		resources deemed in need of conservation;
16	(5)	Provide incentives to local entrepreneurs to cultivate
17		native species, especially those deemed in need of
18	•	conservation, for reforestation programs or
19		sustainable commercial operations; and
20	(6)	Provide support for programs that ensure the
21		sustainability of commercial operations for forest
22		resources deemed in need of conservation in the State.

- 1 §183-C Harvesting of native forest resources deemed in
- 2 need of conservation. (a) All commercial harvesting of native
- 3 forest resources deemed in need of conservation on all lands
- 4 shall be done in accordance with a harvest permit approved by
- 5 the board, and in accordance with the provisions regarding
- 6 conservation of aquatic life, wildlife, and land plants and the
- 7 provisions regarding environmental compliance.
- **8** (b) It shall be unlawful to harm, destroy, or harvest any
- 9 material of a forest resource, living or dead, deemed in need of
- 10 conservation for commercial purposes without a harvest permit
- 11 issued by the board.
- 12 (c) It shall be unlawful to export any material of forest
- 13 resource, living or dead, outside of the State for commercial
- 14 purposes except as granted under a harvest permit issued by the
- 15 board.
- 16 (d) Native Hawaiian sandalwood, including all Santalum
- 17 species endemic to Hawaii, is hereby deemed a forest resource in
- 18 need of conservation.
- (e) The department shall adopt rules pursuant to chapter
- 20 91 to effectuate the purposes of this section.
- 21 §183-D Permits. (a) Pursuant to chapter 91 and based on
- 22 a harvest and reforestation plan, the department shall adopt



- 1 rules regarding the issuance of a permit to destroy, harvest, or
- 2 export for commercial purposes any material of a forest
- 3 resource, living or dead, deemed in need of conservation,
- 4 pursuant to section 183-C(a). These rules shall specify the:
- 5 (1) Requirements to obtain a harvest permit;
- 6 (2) Duration of a harvest permit;
- 7 (3) Terms and conditions of a harvest permit; and
- 8 (4) Disqualifications that will prevent the approval of a
- 9 harvest permit.
- 10 (b) No harvest permit or license for the commercial
- 11 harvest or exportation outside of the State of any material of a
- 12 forest resources, living or dead, deemed in need of conservation
- 13 shall be issued by any officer or agency of the State without
- 14 the prior approval and concurrence of the board. In determining
- 15 whether to grant or withhold such approval, the board shall be
- 16 quided by the standards set forth in chapter 183.
- 17 §183-E Fees. (a) The board shall establish a processing
- 18 fee for permits issued for the harvest of forest resources
- 19 deemed in need of conservation. Such a permit will require an
- 20 approved harvest and reforestation plan by the board. The
- 21 process for the development and approval of plans and permits
- 22 will be defined in the rules.

         §183-F Criminal penalties. Any person who violates

    section 183-C, upon conviction thereof, shall be guilty of a
    misdemeanor and shall be fined not more than $2,000, or

    other penalty imposed under this section, fines and penalties in

    accordance with sections 183-5 and 183-18 shall be levied for

    each individual forest resource illegally harvested under

    section 183-C. Fines collected pursuant to this section shall

7	matured, penalties that were incurred, and proceedings that were	
8	begun before its effective date.

10	1 of this Act, the revisor of statutes shall substitute	
11	appropriate section numbers for the letters used in designating	
12	the new sections in this Act.	
13	SECTION 5. Statutory material to be repealed is bracketed	
14	and stricken. New statutory material is underscored.	

SECTION 6. This Act shall take effect on July 1, 2050.
