## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 251-1, Hawaii Revised Statutes, is		
2	amended as follows:		
3	1. By adding a new definition to be appropriately inserted

5	"Car-sharing organization" means an organization that		
6	operates a membership program under which its members are		
7	permitted to use vehicles from the organization's fleet on an		
8	hourly or other incremental basis less than one full day."		
9	2. By amending the definition of "rental motor vehicle" or		
10	"vehicle" to read:		
11	""Rental motor vehicle" or "vehicle" means every vehicle		
12	which is:		
13	(1) Self-propelled and every vehicle which is propelled by		
14	electric power but which is not operated upon rails		
15	which is rented or leased or offered for rent or lease		
16	in this State, whether for personal or commercial use,		
17	for a period of six months or less; and		
18	(2) Designed to carry seventeen passengers or fewer.		

1	"Rental motor vehicle" or "vehicle" shall not include:	
2	(1)	Mopeds as defined in section 286-2;
3	(2)	Any trucks, truck-tractors, tractor-semitrailer
4		combinations, or truck-trailer combinations, with:
5		(A) A manufacturer's nominal carrying capacity of one
6		thousand pounds or more; and
7		(B) A barrier or separation between the operator's
8		compartment and the cargo area; [and]
9	(3)	Cargo vans with no more than two seats, including the
10		driver's seat; provided that vans with a recreational
11		vehicle converter package and vans with quick release
12		passenger seats shall not be classified as cargo
13		vans[-]; and
14	(4)	Vehicles that are rented by a car-sharing organization
15		to members of its membership program on an hourly or
16		other incremental basis for a period of up to six
17		hours per day per vehicle."
