## A BILL FOR AN ACT

RELATING TO LAND.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that prior to being		
2	acquired by the State, Waiahole valley was held by the Marks		
3	estate, which was largely undeveloped and consisted of		
4	residences and farming under short-term leases or oral		
5	agreements. The Marks estate sold rights to develop Waiahole		
6	valley for residential use. The sale of development rights		
7	sparked public outcry against the proposed urbanization of rural		
8	agricultural lands. In 1977, the governor authorized the Hawai		
9	housing authority to acquire the Marks estate in furtherance of		
10	the public purpose of preserving the rural agricultural nature		
11	of the valley. The authority acquired the property via a		
12	disbursement of \$6,160,000 from the dwelling unit revolving		
13	fund.		
14	In 1978, the Hawaii housing authority adopted a resolution		
15	setting forth its policies for the future use of Waiahole		
16	valley. The resolution stated that the valley would be		
17	developed as a farming community and include residential,		

commercial, community, and public facilities uses, and that

- 1 viable agricultural lands would be developed to the fullest
- 2 potential feasible.
- 3 Following the completion of condemnation proceedings in
- 4 1986, the housing finance and development corporation
- 5 constructed infrastructure and subdivided the valley into what
- 6 is now known as the Waiahole valley agricultural park and
- 7 residential lots subdivision. In 1993, the legislature enacted
- 8 Act 330, Session Laws of Hawaii 1993, which authorized the
- 9 department of land and natural resources to convey ten
- 10 additional parcels in Waiahole valley to the housing finance and
- 11 development corporation.
- 12 The legislature further finds that the current owner of the
- 13 Waiahole valley agricultural park and residential lots
- 14 subdivision, the Hawaii housing finance and development
- 15 corporation, does not have the expertise in agriculture or
- 16 agricultural lands while the agribusiness development
- 17 corporation does. The Waiahole valley agricultural park and
- 18 residential lots subdivision at present is not being managed and
- 19 developed for agricultural use to its fullest potential.
- 20 The purpose of this Act is to transfer title to the
- 21 Waiahole valley agricultural park and residential lots
- 22 subdivision from the Hawaii housing finance and development



- 1 corporation to the agribusiness development corporation to
- 2 fulfill the public purpose of maintaining the agricultural
- 3 nature of the valley.
- 4 SECTION 2. The following parcels of land, identified by
- 5 tax map key number, are hereby transferred from the Hawaii
- 6 housing finance and development corporation to the agribusiness
- 7 development corporation:

- 1 SECTION 3. All rights, powers, functions, and duties with
- 2 respect to the administration of Waiahole valley agricultural
- 3 park and residential lots subdivision are transferred from the
- 4 Hawaii housing finance and development corporation to the
- 5 agribusiness development corporation.
- 6 Every reference to the corporation or its predecessor
- 7 agencies, the Hawaii housing authority, the housing finance and
- 8 development corporation, and the housing and community
- 9 development corporation of Hawaii, in all deeds, leases,
- 10 contracts, loans, agreements, permits, or other documents
- 11 executed or entered into by or on behalf of the corporation with
- 12 respect to the Waiahole valley agricultural park and residential
- 13 lots subdivision shall be construed as a reference to the
- 14 agribusiness development corporation.
- 15 SECTION 4. This Act shall take effect upon its approval.
