A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that due to the rapid

2 change taking place in the health care industry and the

3 impending implementation of national health care reform, the

4 corporate structure of governance for the Hawaii health systems

5 corporation's board of directors requires the appropriate

6 flexibility and autonomy necessary for community hospitals to

compete and remain viable.

8 The current corporation board membership includes the five

regional chief executive officers serving as ex officio, voting

10 members. In light of the successful establishment of the

11 regional boards and the significant challenges imposed by an

12 ever-changing and complex health care environment, the time

required to serve on the corporation board, and the desire for

14 additional community participation, the legislature finds that

15 it is time to increase the number of community members on the

corporation board. The regional chief executive officers will

continue to participate in the board meetings along with the

president and chief executive officer of Hawaii health systems 1 2 corporation as invited staff. 3 The legislature further finds that changes to the corporation board membership will build on the excellent 4 progress made by the regional boards in coordinating service 5 6 delivery and improving the health of the island communities by 7 supporting clear and consistent roles for all regions and creating a more balanced multi-board tiered system; creating a 8 more balanced playing field for the regions; and enabling each 9 10 region to strengthen the region's focus on quality care and 11 services which respond to the needs of the respective 12 communities. The purpose of this Act is to affirm the State's commitment 13 14 to providing quality health care and to enhance the integrity 15 and function of the regional boards while improving the accountability and sustainability of the health system by: 16 Removing the five regional chief executive officers 17 (1) and the at-large member selected by the governor from 18 19 the corporation board;
