A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that due to the rapid

change taking place in the health care industry and the

impending implementation of national health care reform, the

corporate structure of governance for the Hawaii health systems

5 corporation's board of directors requires the appropriate

6 flexibility and autonomy necessary for community hospitals to

7 compete and remain viable.


The current corporation board membership includes the five regional chief executive officers serving as ex officio, voting members. In light of the successful establishment of the regional boards and the significant challenges imposed by an ever-changing and complex health care environment, the time required to serve on the corporation board, and the desire for additional community participation, the legislature finds that

15 it is time to increase the number of community members on the

16 corporation board. The regional chief executive officers will

17 continue to participate in the board meetings along with the

- 1 president and chief executive officer of the Hawaii health
- 2 systems corporation as invited staff.
- 3 The legislature further finds that changes to the
- 4 corporation board membership will build on the excellent
- 5 progress made by the regional boards in coordinating service
- 6 delivery and improving the health of the island communities by
- 7 supporting clear and consistent roles for all regions and
- 8 creating a more balanced multi-board tiered system; creating a
- 9 more balanced playing field for the regions; and enabling each
- 10 region to strengthen the region's focus on quality care and
- 11 services which respond to the needs of the respective
- 12 communities.
- 13 The legislature also finds that a significant amount of
- 14 time and resources is required for regional system board members
- 15 to gain a solid understanding of the intricacies of the health
- 16 care system. Allowing the regional system boards greater
- 17 flexibility in determining the length of each member's term
- 18 would allow regional system board members to develop their
- 19 knowledge base and remain on the board for longer periods of
- 20 time to support continuity in the work of the boards.
- 21 The purpose of this Act is to affirm the State's commitment
- 22 to providing quality health care and to enhance the integrity

The appointed board members [who reside in the county of 1 Maui, eastern section of the county of Hawaii, western section 2 3 of the county of Hawaii, on the island of Kauai, and on the 4 island of Oahu] shall each serve for a term of four years; provided that the terms of the initial appointments shall be as 5 6 follows: one of the initial members from the county of Maui 7 shall be appointed to serve a term of two years and the other 8 member shall be appointed to serve a term of four years; the 9 initial member from East Hawaii shall be appointed to serve a term of two years; the initial member from West Hawaii shall be 10 11 appointed to serve a term of four years; the initial alternating 12 county of Hawaii member shall serve a term of four years; the initial member from the island of Kauai shall be appointed to 13 14 serve a term of two years; and the initial member from the 15 island of Oahu shall be appointed to serve a term of four years. 16 [The at-large member appointed by the governor shall serve a 17 term of two years.] Any vacancy shall be filled in the same manner provided for 18 19 the original appointments. The corporation board shall elect 20 its own chair from among its members. Appointments to the corporation board shall be as representative as possible of the 21 system's stakeholders as outlined in this subsection." 22



1	SECTION 3. Section 3231-3.3, nawall revised statutes, is
2	amended by amending subsection (c) to read as follows:
3	"(c) Each regional system shall be governed by a regional
4	system board of directors to consist of not less than seven
5	members and not more than fifteen members, as determined by the
6	regional system board after the initial regional system board is
7	established.
8	(1) Each regional system board shall initially consist of
9	twelve members to be appointed by the governor under
10	section 26-34 or as provided in this section, as
11	follows:
12	(A) Four members shall be appointed by the governor
13	within thirty days of receipt of a qualified list
14	of candidates as follows:
15	(i) Two members shall be chosen from a list of
16	four individuals submitted by the speaker of
17	the house of representatives within fifteen
18	days of July 1, 2007; provided that this
19	list shall not include physicians; and
20	(ii) Two members shall be chosen from a list of
21	four individuals submitted by the president
22	of the senate within fifteen days of July 1,

1		2007; provided that this list shall not
2		include physicians;
3	(B)	Four members shall be appointed by the governor
4		within thirty days from a list of eight
5		individuals nominated by the regional public
6		health facility management advisory committee
7		within fifteen days of July 1, 2007. These
8		individuals may be medical and health care
9		providers and professionals, consumers, and
10		knowledgeable individuals in other appropriate
11		areas such as business, finance, and law;
12		provided that these individuals shall not be
13		physicians currently in active practice;
14	(C)	Three physicians shall be appointed by the
15		governor within thirty days from a list submitted
16		within fifteen days of July 1, 2007, of six
17		physicians nominated by a majority vote of the
18		medical staff of the public health facilities in
19		the regional system present at a duly noticed
20		meeting from a list of qualified candidates
21		submitted by the medical executive committees in
22		the regional system; and

1	system board shall be selected by a two-thirds
2	affirmative vote of the existing regional system board
3	members.
4	Except for the ex officio members of each regional system board
5	all other members of a regional system board shall be residents
6	of the region. Each regional system board shall elect its own
7	chair."
8	SECTION 4. Statutory material to be repealed is bracketed
9	and stricken. New statutory material is underscored.
10	SECTION 5. This Act shall take effect upon its approval.

Hawaii Health Systems Corporation; Corporation Board; Regional System Board; Membership

Description:

Adds a member to the corporation board of Hawaii health systems corporation who alternately represents the eastern and western regions of the county of Hawaii. Replaces the regional chief executive officers with community members from each respective region. Removes the at-large member selected by the governor. Changes the regional system board membership term from three years to a membership term between two and five years, as established by a two-thirds affirmative vote of the existing regional system board members.
