WHEREAS, the Centers for Medicare and Medicaid Services has proffered the opportunity for demonstrations to integrate primary, acute, behavioral health, and long-term care services; and

WHEREAS, the Department of Human Services already has Centers for Medicare and Medicaid Services-approved QUEST Expanded Access Medicaid managed care health plans that include Centers-approved dual eligible special needs plans; and

WHEREAS, future QUEST Expanded Access health plans with dual eligible special needs plans would be expected to join the integration demonstration; now, therefore,
