## SENATE RESOLUTION

REQUESTING THE DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT TO CONVENE A TASK FORCE TO EXAMINE MANAGEMENT POLICIES REGARDING THE USE OF OVERTIME BY STATE AND COUNTY EMPLOYEES.

WHEREAS, the Hawaii Employees' Retirement System has an unfunded liability of approximately \$8,200,000,000; and

WHEREAS, the amount that employees and their employers are required to contribute to the Employees' Retirement System each year is determined in part by base salaries, while the actual pension payments are based on the three years with the highest overall compensation, which includes overtime, differentials, and other supplemental pay; and

WHEREAS, a small number of excessive overtime cases can drive up the costs of the Employees' Retirement System significantly; and

WHEREAS, overtime is authorized by supervisors, and thus management of employees' time and work attendance is a critical factor in the determination of overtime; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-sixth Legislature of the State of Hawaii, Regular Session of 2012, that the Department of Human Resources Development is requested to convene a task force to examine management policies regarding the use of overtime by state and county employees; and

BE IT FURTHER RESOLVED that the task force is requested to include the following members or their designees:

- A member of the House of Representatives appointed by the Speaker of the House of Representatives;
- (2) A member of the Senate appointed by the President of the Senate;
