Your Committee received testimony in support of the nomination of Howard West from the Small Business Regulatory Review Board; 50th State Management Corporation; Grace Pacific Corporation; Environmental Science International, Inc.; Mid Pac Petroleum, Goodsill Anderson Quinn & Stifel; Hawaii Farm Bureau Federation; and one individual.

Howard West is the Executive Vice President and a founding member of Environmental Science International (ESI), where he is responsible for technical oversight and direction for all ESI projects.
