"A BILL FOR AN ACT RELATING TO THE CREATIVE MEDIA INDUSTRY,"

The purpose of this measure is to authorize the Department of Land and Natural Resources to lease public land for purposes of developing creative media production and post-production facilities by negotiation and without public auction.

The Mayor of the County of Maui and SHM Partners Film Studio Group testified in support of this measure. The University of Hawaii at West Oahu testified in support of the intent of this measure.
