The purpose and intent of this measure is to authorize the
Hawaii Health Systems Corporation to bring the Hawaii Medical
Center-East facility under its governance through formal
affiliation or acquisition.

Your Committee received testimony in support of this measure
from the Hawaii Health Systems Corporation.

Your Committee finds that by establishing a public-private
partnership between the owners of the facility previously known as
the Hawaii Medical Center-East and the Hawaii Health Systems
Corporation, this measure provides crucial long-term care and
other health care services in the State.

Your Committee has amended this measure by inserting an
effective date of July 1, 2050, to allow for further discussion.


As affirmed by the record of votes of the members of your
